## **Executive Summary**

The Motor Pool Program offers a shared pool of vehicles and carsharing options for County use, enabling County employees an accessible and convenient option for work-related travel. By providing this mode of transportation, employees can get from A to B and back without having to worry about parking headaches, mileage reimbursements, and other time-consuming administrative tasks.

# **Program Summary**

The goal of this program is to offer County employees accessible and convenient options for work-related travel.

There are two County owned Motor Pool sites supporting the County's short-term business transportation needs. In addition, County employees located in the Portland Metro downtown area can access the CarShare program or car rentals via Enterprise. The CarShare program supports both Health and Human Services Departments employees' transportation needs. County employees working for these departments regularly travel to meet the people they serve, which directly supports the County's mission to improve equity and inclusion to programs and support. The Enterprise car rentals help round out our options and allow us access to a large supply of vehicles. Our strategic blend of County-owned and vendor-supported motor pools provides County employees with accessible and convenient options for work-related travel.

We include County Departments in our decision making process and try to align the program's strengths and funding with the County department's goals to provide a more equitable and inclusive service. For example, after conversations with department leadership, we realized our passenger vans were supporting several social programs which directly improve equity and inclusion across the County. Committed to supporting equity and inclusion, we realigned our funds to purchase two 15 passenger vans for the motor pool. These additional vans will provide our clients with more accessibility and increase their capacity to support our community into the future.

CarShare service were closed due to COVID and the County's telework mandate. Motor Pool leadership shifted County staff to use Motor Pool resource and Enterprise rental car services. These shifts in services during the pandemic provided support and essential transportation to County programs which added in the support to our community during this emergency.
