- b. On or about October 5, 2018, judgment was entered in Multnomah County Circuit Court foreclosing the delinquent taxes levied against the Property.
- c. On October 6, 2020, the County Tax Collector deeded all right, title and interest in the Property to Multnomah County as authorized under ORS 312.200.
- d. Former Owner has applied to the County in compliance with MCC Section 7.402 to repurchase the Property for \$59,173.26, an amount consistent with ORS 275.180 and MCC Subsection 7.402(B). The County has received payment in the amount of \$59,173.26.
- e. It is in the best public interest that the Property be sold to the Former Owner as described above in Paragraph d).

The Multnomah County Board of Commissioners Resolves:

The County Chair is authorized to execute a deed, in substantial conformance with the attached deed, conveying the Property to Laura Dessert.
