Preschool for All Overview

Voters in Multnomah County overwhelmingly supported "Preschool for All" on Nov. 3, 2020 with 64 percent of voters approving the measure. Preschool for All (PFA) will give 3 and 4 year olds in Multnomah County access to free, high-quality, developmentally appropriate, culturally responsive preschool experiences.

The <u>Preschool for All Plan</u> reflects more than two years of engagement with community members including parents, educators, culturally specific organizations, policy makers and early childhood specialists and will be the framework for program implementation. Preschool for All:

- Allows families to choose the type of preschool experience that is right for their child,
- Increases wages and provides professional development for early educators, and
- Invests in coaching and other key supports for preschool providers.

Preschool for All will grow over time, increasing the number of children and families that it serves each year. All families in Multnomah County will be eligible to apply and families who currently have the least access to high-quality preschool will be prioritized for the first-available slots.

What is the Pathways Program?

The Pathways Program will partner with preschool providers to support quality improvement and professional growth. Pathways Providers can engage in training and educational opportunities, business development, peer networks, and individualized coaching. Supports will be tailored to the strengths and needs of each provider.

All preschool providers in Multnomah County are eligible to apply for the Pathways Program, regardless of licensing status, education level, or setting type. The Pathways Program has been designed to meet the needs of home based providers, as well as other types of providers. There is no deadline for applications to be submitted, providers can apply at any time.

Pathways Providers are not guaranteed Preschool for All slots. Slots will be awarded through a separate process starting in Fall 2021.

- 1. Wait for your application to be reviewed. If your application is complete, you will receive your welcome email and self-assessment within 4 weeks.
- 2. Complete your self-assessment
- 3. Send in your self-assessment, W-9, and invoice (we will provide a template)
- 4. Receive a check for \$500 within 4-6 weeks
