1. Welcome and Introductions

Councilor Kranz and Jessica Berry welcomed the group. Councilor Kranz moved forward with introductions asking participants and members to use the chat feature to introduce themselves...

3. Review and Adoption of Prior Meeting Minutes

4. ODOT'S Proposed Applications to FHWA's Grant Program including the Waterfall Corridor – Hector Rodriguez/Staff, ODOT (00:01:30)

Information/Discussion

Terra Lingley, along with Valerie Egon, ODOT provided the group with Gorge transportation updates affecting the East County community (00:01:30), followed by opportunities for questions and comments (00:17:04).

Topics included in the discussion were:

- 2019 Congestion and Safety Plan Update (00:01:30)
- "Waterfall Corridor" 2021 Operations Update (00:07:56)
- Preparations for 2022 (00:12:39)
- Applications to FHWA Federal Lands Access Program (00:15:19)

Highlights mentioned in comments and question period were (00:17:04):

Both shuttle providers and transit providers will be providing numbers on ridership and operate their own parking lots so they may be able to also provide numbers on how many cars were taken off the roads.

Both are still anticipating continuing to operate in 2022.

Current ODOT lot in Troutdale (south side) will be used for the park and ride.

Councilor Craddick commented on progress and gave kudos on improvements and asked if Troutdale outlet mall had been contacted about participation. Terra and Valerie mentioned that it has been hard to identify who owns/leases that area, how to configure the parking lot and what amenities would be for users. Councilor Craddick mentioned Ray Young, City Manager may have contact information.
