	 Joanna CareAssist Federal Poverty Limit increased to 550% as of Oct 1. Already have 4 folks reenroll. Encourage people who were dis-enrolled due to too much income to reapply. We have expanded our vaccine program to provide vaccines to all CareAssist clients at preferred CareAssist pharmacies, regardless of insurance, so that would include folks in our Uninsured Person (UP) program and our Bridge Program.
