PROCLAMATION NO. 2022-041

Proclaiming May 2022 as Asian American, Native Hawaiian and Pacific Islander Heritage Month in Multnomah County, Oregon.

The Multnomah County Board of Commissioners Finds:

1. The month of May 2022 is nationally recognized as a time to celebrate the contributions of Asians, Native Hawaiians and Pacific Islanders.
2. The month of May was chosen as Asian American and Native Hawaiian/Pacific Islander (AANHPIs) Heritage Month to commemorate the immigration of the first Japanese citizen, Nakahama Manjiro, to the United States on May 7, 1843, and to honor the anniversary of the completion of the first Transcontinental Railroad, on May 10, 1869. This incredible feat was accomplished due to the back-breaking labor of nearly 20,000 Chinese immigrants.
3. AANHPI communities have lived and worked in Oregon for over 200 years, contributing to the state's rich history, economy and culture. Notably in the early 1800s, Native Hawaiians and Pacific Islanders made the crossing to the Pacific Northwest to help establish fur trading posts along the Oregon Trail. In the late 1800s and early 1900s, South Asians migrated to towns up and down the west coast, working in lumber and agriculture.
4. Throughout their history in the United States and in Oregon, AANHPI communities have been subject to discrimination and violence. In 1910, White laborers led an anti-Asian attack on South Asian laborers in the St. John's neighborhood. With the backing of the Multnomah County District Attorney's Office, the South Asian laborers fought back, and demanded the prosecution of these attacks. More recently, Asian communities have been the target of anti-Asian hate that has been fanned by misinformation and bias related to the COVID pandemic. AANHPI history is both heroic and harrowing, as these communities have thrived despite harassment and discrimination.
5. Asian Americans, Pacific Islanders and Native Hawaiians have made significant contributions in various aspects of our society such as the arts, law, science, technology, sports and public service. This year we are lifting up AANHPI individuals who are committed to advancing future leaders through collaboration. Supporting and advancing AANHPI community leaders is essential to developing leadership opportunities, inspiring individuals and advancing Multnomah County's diverse and vibrant culture.

6. Multnomah County is committed to learning from and working with our AANHPI partners to eliminate disparities by removing impediments to success through increasing social inclusion, reducing poverty, ensuring language and healthcare access, and supporting meaningful civic engagement.
7. Multnomah County welcomes and supports Asians, Asian Americans, Pacific Islander and Native Hawaiian Oregonians as vital members of our community. The county is committed to continuing to actively work with the community to use county systems of care to provide our residents the safety they deserve. Multnomah County is also committed to collaborating with the AANHPI community to mentor and uplift future leaders.

The Multnomah County Board of Commissioners Proclaims:

The month of May 2022 as Asian, Asian American, Native Hawaiian/Pacific Islander Heritage Month celebrating all residents of Multnomah County who identify as Asian, Asian American, Native Hawaiian and/or Pacific Islander.
