Equity Lens

- Each LPSCC project centers race and racial equity:
 - Justice Reinvestment Program
 - Safety + Justice Challenge Pretrial reform
 - Transforming Justice
 - Justice Fellowship/partnering with OCI
- New violence prevention position will prioritize communities most impacted by violence.



Workforce Equity Strategic Plan (WESP) Update

In addition to equity and policy work, WESP highlights include:

- Hired of OCI Justice Fellowship Coordinator
 - LPSCC/OCI partnership
 - Granting to community organization
 - Focus on increasing equity
- Launching racial reckoning events; planning with the Square One Project (more information available soon!)
- HR collaboration to improve recruitment
- HR and ODE collaboration to increase retention
- Ongoing team discussions on policy, equity, and race



Significant Program Changes/New work

- OTO program offer 10009C (\$250,000 CGF) to fund implementation of Transforming Justice core strategies
- New 1.00 FTE ongoing position (PO 10009D \$175,000 CGF) to fund community violence prevention coordination (Project Manager – Community Violence Coordinator)



Successes – a few highlights from FY 2022

- 1. Transforming Justice vision will be complete 6/30/22
- Ongoing monitoring of Justice Reinvestment; including policies, impact on RED, and case backlog
- Applicant for several CJC grants, including MCJRP and specialty courts
- 4. Launch of Justice Fellowship planning
 - New MacArthur funded position
 - Procurement underway for CBO/curricula development
 - Goal: co-create policy strategies to decrease RED
- Ongoing management of Safety + Justice Challenge pretrial overhaul
- 6. Continued role as national leader for collaborative system change



State/Federal Impacts or Other Policy Issues

1145 state funding:

Dependent on state, LPSCC 'core' functions

3194 justice reinvestment:

Dependent on state decisions and CJC grant-making

MacArthur SJC funding:

Final grant: funds through 12/2023 (may last into CY 2024)

Transforming Justice:

 TBD, but exciting opportunities for policy, budget, and legislative change
