

Question 3

Commissioner Jayapal (District 2): Please provide the planning budget for the partners (i.e. City of Portland) that are participating in Behavioral Health Emergency Coordination Network (BHECN 40000E).

Response: Here are the planning budgets from the City of Portland for BHECN. Phase 1 ended in October 2021. Phase 2 ends in September 2022.

Phase 1 (November 2020- September 2021)

- \$159K split between the City of Portland and CareOregon Lones consulting (Aaron's contract)
- \$5K OJD /\$20K City of Portland Funding for City project staff (Bob's contract)
- \$486K from Legacy Health to Cascadia BH to engage subject matter experts on community engagement and diversity, equity, and inclusion. Also allocated some to pay for BHECN Lived Experience Consultant stipends, and some to a subrecipient arrangement with Lones consulting to add additional support.

Phase 2 (October 2021 - September 2022)

- \$765K City of Portland PM team
- \$400K City of Portland PM team (through ~July 2022)
