

VISITING RULES for JUVENILE DETENTION

Location / Address -> 1401 NE 68th Ave. Portland OR 97213

VISITOR ACCESS:

- PARENTS / LEGAL GUARDIANS / DESIGNATED ADULTS / PROFESSIONAL LIAISONS are cleared by the assigned JCC/PO prior to visitors being allowed to schedule a visit via 503-988-5624.
 Professional visitors (legal reps, JCCs/POs, psychologists, mentors, etc.) may email visit-access@multco.us
- Visitors over the age of 12 must provide one of the following forms of ID:
 - Sovernment ID (Driver's License; State ID; Military ID; Immigration certificate/ID; Passport; School ID)
 - ➤ Work agency ID that includes a photo
 - ➤ Birth certificate
- NO WEAPONS of any kind may be brought into the building.
- NO ELECTRONIC DEVICES (cell phones, cameras, smart watches, bluetooth gadgets, etc.).
- NO FOOD, BEVERAGES or GUM.
- COATS, PURSES, HATS, BACKPACKS, WALLETS, KEYS, ELECTRONICS and any other personal possessions are to be stored in lobby lockers or left in vehicles.
- DRUGS, ALCOHOL, TOBACCO products or LIGHTERS are NOT allowed in the building.
- NO BOOKS OR MAGAZINES. Religious pamphlets/paper materials will be allowed.
- NON-ELIGIBLE VISITORS / children are **NOT** allowed to wait in the Visiting Lobby.
- PROHIBITED VISITOR ATTIRE: Clothing with images of drugs / alcohol / violence / profanity / gangs / sexually explicit images; Cropped or revealing shirts; Skirts / shorts more than 2 inches above the knee.
- Failure to follow the rules will result in terminated visits and/or impact on future visit access.

VISITING DAYS/TIMES:

30-min time slots are offered every day 9:00am to 11:30am and 1:30pm to 5:00pm Evening time slots -- Monday through Thursday 6:30pm to 8:00pm 60-min time slots are offered to Level 3 and 4 youth, as space allows

"SHORT TERM" STAY YOUTH (44 days or less):

- 1-2 visitors per visiting slot to include parents, legal guardians, siblings 18 or older, surrogate parents or grandparents.
- 3 personal visiting sessions per week Sat through Fri schedule.
- Attorney / legal representative, case managers, mentors, religious or tribal support are permitted.
- Brief hugs at the beginning and end of the visit are permissible. No other contact is allowed.

"LONG TERM" STAY YOUTH (45 days or more):

- Eligible for expanded family member visiting list access that includes siblings under the age of 18.
- 3 personal visiting sessions per week Sat through Fri schedule.
- Brief hugs at the beginning and end of the visit are permissible. No other contact is allowed.

OTHER INFORMATION:

- > A youth may refuse/decline any visit.
- A youth's biological child may visit. Request to speak with a manager for arrangement.
- Hair braiding may be arranged. All product necessities are provided by the facility.

MAIL: All letters must be routed through USPS mail (Youth Name - DELH, 1401 NE 68th, Portland OR 97213).

MEDICATIONS: Prescriptions may be brought to the facility to be directly passed to Corrections Health.

PERSONAL PROPERTY: Youth receive an itemized receipt when admitted. Any release requires both the youth's and the receiver's signature. Detention managers facilitate property release. Clothing for court may be brought during visiting times.

PHOTOS: Up to **5** photos may be brought to a visit and passed to staff for the youth to take to their room.
