

Community Involvement Committee // Scope

Multnomah County Code: CIC

(section 3.251 Duties)

- (A) Identifying community needs, concerns and opportunities regarding community involvement in county-decision making, and providing information to the OCI.
- (B) Serving as a resource for the OCI in developing and evaluating community outreach and input plans, and providing recommendations for community members to involve in input processes.
- (C) Working with the OCI to develop countywide community involvement best practices and advise on reducing barriers to civic participation and engagement.
- (D) Assisting in facilitating communication between county elected officials, employees and the community by informing the community of involvement and input opportunities.



Community Involvement Committee // About

Role of OCI

- Provide staff support to Chairs, Co-Chairs, Subcommittees and Committee
- Ensure transparent public process
- Develop bylaws, policies and procedures
- Research and facilitation support
- Support Membership outreach process



Membership: 7-15 members

Time Commitment: bimonthly 2 hour meeting, which will typically require 1-2 hours of prep time. Optional: additional time spent on subcommittees and/or in leadership roles.

Terms: 3 year terms, and can serve up to 2 terms in a row (6 years)

Districts: Must represent all districts



Meeting Details

Location: Currently on Zoom, next cohort will decide between fully remote and hybrid meetings

Stipend: optional \$35 stipend per meeting

Access:

- Interpretation available
- Wifi hot-spots and laptops available for loan



CIC Year

September: CIC Retreat- team building and selecting topics for Subcommittee work

October-April: Subcommittees meet with County staff and develop recommendations, Membership subcommittee works on

April- June: CIC confirms Subcommittee Recommendations and Membership, presents both to Board of County Commissioner

Applications due (priority): Friday, March 17th

Final due date: Friday, March 31st

Application review: March 20-28

Interviews and finalists notified: April 11-21

CIC Approval of Nominees: May 16th

Notification to Applicants: by May 19th

Board Appointment: June 2023



Community Involvement Committee // Application - questions

Application Questions

- Why are you interested in joining the Community Involvement Committee? What perspective, experience, or skills do you hope to bring to the group?
- Describe a time you were part of a group working towards a common goal. What were your contributions and how did you grow with that experience?
- What has been difficult for you when working in groups where including all voices, working together across differences, and equity are critical values? How have you addressed those challenges?
- The Community Involvement Committee is committed to reducing barriers to participation for communities that have been typically underrepresented in the County decision-making.
 Describe your experiences with local historically marginalized and underrepresented communities.
- In your opinion, what are the top three barriers to civic participation and community involvement in county decision-making?
- Please state any potential conflicts of interest you may have related to any county department, if applicable. Eg. If you are an employee or a board member for an organization that receives county funding and/or has contracts with the County.
- Please provide us with a summary of your work and volunteer experience (written response or attach a resume).
- How did you learn about this opportunity?
- Is there anything else you'd like us to know?



Scoring Criteria

Interest in Work of Multnomah County

- The applicant expresses a sincere interest in public service and community involvement. (3 pts)
- The applicant demonstrates knowledge of the county's programs and services.(1 pts)
- The applicant has experience as a client of Multnomah County's programs and services (1 pts, may change to 2pts)
- The applicant demonstrates an understanding of the role and responsibilities of the CIC and an alignment with the county's values of safety, trust and belonging. (5pts)



Community Involvement Committee // Application - criteria

Community Involvement & Engagement

- The applicant has a demonstrated history of community involvement and/or is actively involved in their community/communities. (2 pt)
- The applicant has experience with community engagement and outreach. (1 pt)



Community Involvement Committee // Application - criteria

Skills & Life Experience

- Experience in and/or commitment to shared leadership, consensus-building, and working across difference. (2 pts)
- Brings knowledge, skills, and/or life experience that would inform and enrich the CIC's deliberations and would add a perspective not currently represented on the CIC. (3 pts)
- Personal, professional, and/or lived experience with communities impacted by the county's policies, programs, and services and typically underrepresented in decision-making (immigrants & refugees, communities of color, LGBTQ, rural residents, homeless, mental health, etc). The CIC prioritizes applicants with lived experience applicants that provide examples of their lived experience in their application should receive the highest scores for this criteria. (5 pts)
