What Does this position Do?

We conducted user research and designed and deployed a new software catalog that contains all of the software that can be obtained at Multnomah County.

What we need is to clean up the backlog of low quality data that needs to go into the inventory and the customer-facing software catalog. The intern would need to research each software title (about 1,000), find the missing data elements (status, date of status, owner, restrictions of use, short description, etc.) and update the inventory. That is, all the data elements in the software model form that the Service Now team needs to create the software model (inventory) and to decide whether to publish it in the customer facing software catalog. The intern would also categorize the inventory and potentially make recommendations or changes to existing processes to support the building of the customer facing catalog. This is an evolving body of work so there will also be other work assignments as they emerge.

Internship Description & Responsibilities:

 Research data quality and prepare data for entry into official record of software asset inventory





- Work with other Business System Analysts, Customers, and IT staff to gather information
- Collect data on the type of software, why it is used, and how it is being used currently
- Write a short product description for each product
- Enter data into the ServiceNow system, Software Catalog
- Present the final products and decision to decision-makers

- Learn about IT service delivery models, software asset models, and licensing
- Develop and build skills in business analysis, technical documentation, and customer service
- Learn how different software systems are used in a large organization
