# What Does the Voter Education and Outreach Program Do?

The Multnomah County Elections Division conducts all local, state, and federal elections by mail for the 566,000 registered voters in our county. During this internship you will learn all the functions of a vote by mail election process.

The Voter Education and Outreach program provides education and outreach to current and future voters in Multnomah County towards: *voter registration, voter assistance resources, and voting a ballot by mail.* We deliver and assess the needs of voters through our culturally specific outreach efforts. Our efforts are directed by a racial equity lens and use a trauma informed framework to guide how we do our work.

### **Internship Description & Responsibilities:**

- Lead others in conducting outreach at community events on behalf of the Elections Division.
- Develop relationships with community partners and conduct intake interviews to assess needs and collaboration opportunities.
- Conduct workshops for community partners on: Voter Registration, Vote by Mail, and Civic Engagement topics.
- Conduct surveys with eligible voters to determine barriers to: Voter Registration, participation, and habit formation.
- Participate in the Elections Communication Team Workgroup and collaborate on the development of communication plans directed towards Voters.

- Learn the functions and operations of a municipal Elections Division
- Learn racial equity based community outreach and voter education principles, practices, and strategies
- Develop an understanding of program development, evaluation, and quality improvement processes.

- Strong interpersonal communication skills, informed by a racial equity and trauma informed lens.
