### What Does the Integrated Clinical Services do at the Health Department?

Multnomah County Integrated Clinical Services (ICS), a division of the Health Department, operates the Multnomah County Community Health Center, which provides health services for people who experience barriers to accessing health care, including people who are experiencing poverty, uninsured, and/or homeless.

#### Internship Description:

This position will work alongside the credentialing specialist to develop, implement, monitor and provide ongoing evaluation of the Health Department's Credentialing, Privileging and Licensing Program. This role requires extensive coordination and collaboration between the program and community organizations, contractors, other County departments, and other public agencies at both the state and federal level. While working with the Credentialing Specialist you will maintain confidential credentialing files and provider database and will be responsible for communicating with clinical directors and the clinicians regarding credentialing, privileging, and licensing.

#### **Responsibilities include:**

- Data entry and maintaining of appropriate credentialing software/database.
- Act as a representative of the program with service providers and funding sources.
- Tracks and notifies providers when updated information is needed, e.g. license.





- This position ensures that all appropriate documents, including practitioner licensure, are submitted to ensure coverage for these practitioners.
- Responsible for ensuring external credentialing process for insurers and Medicare/Medicaid enrollment/reassignment of benefits performed in accurate and timely manner.

- Demonstrated ability to work with diverse populations
- Strong oral and written communication skills, including public speaking skills
- Ability to work independently and be flexible
