Timeline and what does this mean? <ul style="list-style-type: none"> ○ The Housing Multnomah Now pilot runs 1/2023-1/2024 and 'resolving' means that people will be connected to services (but may not yet be housed) ● What is the Housing Multnomah How budget ask? Cost per person served? <ul style="list-style-type: none"> ○ The budget ask is \$4 million to for the pilot (more info: https://www.multco.us/multnomah-county/news/board-approves-4-million-funding-housing-multnomah-now-pilot-project & https://www.youtube.com/watch?v=yYW-Q2gR8vU [41 minute mark]) ● What are the occupancy rates of motel/non-congregate shelters? <ul style="list-style-type: none"> ○ Answer pending ● What is the breakdown for the per unit cost of shelter? <ul style="list-style-type: none"> ○ [note: JOHS uses 'unit' for shelter measurement vs 'bed'] ○ Answer pending. ○ Each kind of shelter has a different per unit cost. Congregate shelters are the least expensive, and 50% of shelter units are congregate shelters ● What funds pay for shelter? <ul style="list-style-type: none"> ○ While shelter is primarily funded under our 'Safety on and off the Street' division, shelter funds come from multiple divisions. Shelter funds currently come from City of Portland funds, American Rescue Plan, and Supportive Housing Services (SHS) funds
