## **CBAC Budget Feedback**

#### **EMERGING ISSUES & CHANGES**

We focused on supporting programs that prevent evictions and increase housing stability, support immigrants and refugees and those affected by domestic violence, and build economic security for communities of color.

#### **BUDGET FEEDBACK**

Our recommendations for DCHS and the County's budget overall is to focus on observation of process, opinions and ideas facing the community by:

- Supporting system-wide collaboration using a racial justice lens
- Developing new relationships with other stakeholders who aren't at the table
- Improved planning for responding to extreme weather events



### CBAC Recommended Program Offers

#### PROGRAM OFFER PRIORITIES

The DCHS CBAC recognizes the essential services that the County provides as a social safety net for the County's vulnerable residents, particularly in light of the impact and aftermath of COVID-19 and the inequalities resulting from oppressive systems, both historic and contemporary.

Accordingly, our specific recommendations are as follows, in priority order:

- 25118B Expand Staff Capacity YFS Infrastructure \$287,244 (Ongoing)
- 2. 25133B Housing Stability Team Eviction Prevention Specialist \$151,437; 1.00 FTE (Ongoing)
- 3. 25490B Emergency Rent Assistance \$8,078,059 (ARP)




# Applying an Equity Lens to Our Everyday Work


# Organizational Chart




## Budget by Fund - \$332,249,512






## **6 Year Trend of Significant Funds**






### Budget by Division (\$332,249,512 and 994.72 FTE)







#### Increase KSA Workforce









### **IDD: Client Demographics**



#### Race\*





- Oregon Project Independence Medicaid (OPIM) & Family Caregiver Assistance Medicaid (FCAP) - \$3.7 million
- Oregon Money Management Medicaid (OMMP)

#### Housing Navigator

Medicaid Funded - \$112,533

#### Resource Management

- Program moves: Adult Care Home Program, Long Term Services & Supports
   Transition and Diversion and space consolidation in 5 Oak building
- Ending lease at Cherry Blossom

#### Covid Call Center

- Now called the Regional Health & Human Services Contact Center PO 25032B - \$1.3 million
- Funded by Health Share for FY 2024
- Homeless Mobile Intake Team funded by Supportive Housing Services (SHS)
  - 4 Case Managers, 1 Case Manager Assistant



### ADVSD: Homeless Mobile Intake Team (HMIT)

The Homeless Mobile Intake Team (HMIT) meets with homeless individuals to offer mobile Long Term Services & Supports (LTSS) assessments, SNAP and medical eligibility, and short-term intensive housing case management.



### ADVSD: State/Federal Impacts or Other Policy Issues

- End of COVID-19 Public Health Emergency (PHE)
  - Ended Emergency Allotment funds for SNAP
  - Redetermination reviews resumed April 1, 2023
- House Bill 2495: Adult Care Home rate funding in committee to raise rates 50%. Increase needed to place people in proper care setting.
- Community Services Procurement
  - \$7.2 million out to contractors
  - Services include: Transportation, Nutrition, Information & Referral, & More







## YFS: Significant Program Changes

- YFS Infrastructure (25118B \$287,244)
  - Adds 2.00 FTE to enhance YFS contracting and data reporting capacity.
- Woodstove Exchange (25121B \$244,283)
  - FY 2024 funding continues our environmental justice work in partnership with the Office of Sustainability and Environmental Health; OTO funded positions allows YFS to take on other resources to promote climate justice in Multnomah County.
- Domestic and Sexual Violence Services (25399C \$813,784)
  - Continuation of ARPA funds support direct staff and culturally specific domestic violence programming in the community.
- **SUN Community Schools & Food Pantries** (25145B, 25147B & 25399S \$476,222)
  - Funds continuation of 4 SUN Community School sites in east Multnomah County and preserves critical food support at SUN Food Pantries.



### YFS: State/Federal Impacts or Other Policy Issues

- Expiration of pandemic-related federal rent assistance and reduction in Multnomah County ARPA, and City allocations, for rent assistance
- Changes in tenant eviction protections
- Anticipated funding through Governor's Executive Order for eviction prevention will continue YFS' Rapid Response Eviction Prevention program as a priority area for FY 2024
- Increase in Weatherization Funds as a result of federal legislation
- Procurement for the SUN Service System





### COVID 19 & ARP: Significant Program Changes

#### FY 2023:

- SUN Family Resource Navigators
  - Family Resource Navigators helped families connect to resources such as case management, language support, skill building, and more. Program will be ramped down.
- Unconditional Cash Transfer / DCHS Client Assistance
  - Distributed unconditional cash transfers (primarily \$500 VISA gift cards) to Multnomah County households via DCHS staff and partners. Program will be ramped down.
- **Bienestar Wraparound** (Health Dept)
  - Supported impacted families with food, rent/mortgage payments and utilities/bills as they recovered from COVID-19 and other respiratory illnesses. Program has been ramped down.

#### FY 2024:

- Multnomah Mothers' Trust Project (25399B \$1,350,000)
  - This program invests in and trusts 100 African American mothers to move towards basic income levels for participants, addressing systemic inequities in salary and wealth.
- Emergency Rent Assistance (25490B \$8,078,059 and 25490C \$1,921,941)
  - Supporting families to remain stably housed. Program continues in FY 2024 at a reduced funding level.
- **Domestic Violence Services** (25399C \$813,784)
  - Culturally-specific community-based advocacy services and system-based advocacy embedded with law enforcement.
- **COVID-19 Energy & Housing Services** (25491 \$1,762,843)
  - Provides energy and water assistance, weatherization and housing supports focused on low income households. Program continues in FY 2024 at a reduced funding level.
