Councilor Glantz provided the committee with a report on the Region 1 ACT meeting held December 4th that included the following highlights:

- Work Plan was moved from October to December and will now be moved into a meeting tonight
- Discussion on Interstate Bridge replacement; it may require 18,700 jobs in construction. The discussion included reaching out to high schools and colleges because that labor isn't currently available and how this might slow the project down.
- Also discussed was the possibility of overlap between the Rose Quarter project and the Interstate Bridge project, the strain on jobs, and homelessness issues that may arise.
- Election for the Aviation Review Committee for the State of Oregon from Region 1 was also discussed.
