

<ul style="list-style-type: none"> Volume Pricing for Hosted Catalog Items - The ability is being added for suppliers to submit hosted catalog item price files that contain discounts based on volume purchases. Shoppers can see the volume pricing offers when searching for items, and the price will reflect the volume price when the item is added to their carts. For example, if a quantity of 1 of item ABC is purchased, its price is \$10. However, if five are purchased, the price goes down to \$9.50.

<ul style="list-style-type: none"> Supplier Search New - A new experience view for Supplier Search has been available for the past two releases. The new user interface provides a consistent, modern, and end-to-end experience for users with easier access to important functions, enhancing the user experience. Based on the devices being used, desktop, tablet or mobile, the new responsive layout also offers adaptive display sizes for user convenience. <p>From the “Search for a Supplier”, a “Choose Your Experience” toggle  at the bottom-right of the screen allows users to switch between the new and classic views at any time.</p> <p>Important Note: The new experience view for supplier search will be fully activated for all organizations with the 24.2 release. The toggle to return to the classic view will no longer be available with 24.2. We encourage users to use the new experience as much as possible during the 24.1 version in order to become familiar with the interface and functions.</p> <ul style="list-style-type: none"> Supplier Profile Updated - With this release, the Legal Structure for selection in the supplier profile for “<i>Individual/Sole Proprietor</i>” has been renamed to “<i>Individual/Sole Proprietor or Single Member LLC</i>”. This value will show in the Legal Structure drop-down in the buyer’s view of the supplier profile, to suppliers when registering, and to suppliers completing or editing their registration in the Supplier Network or Customer Branded Portal.

Contracts+
<ul style="list-style-type: none"> PDF Document Preview - Currently, users can only view attachments stored in Contracts+ by downloading them to their devices. In the 24.1 release, we are updating the viewing function of PDF attachments so that users may view them directly within Contracts+. Users may still download the attachments if they wish, but downloading will no longer be the default behavior.

- **Allow Full Contract Documents in External Communication Emails** - The ability is being added for users to choose the executed contract to be included in an external email sent from the Communications Center. Users will be able to select either the fully executed contract or the full contract PDF to include. This functionality will respect the Allow attachments in email communication setting for the organization, allowing organizations to restrict this functionality if desired.
