## Multnomah County Department of Community Justice Domestic Violence Unit

The DV Unit consists of 16 Parole/Probation Officers, 2 Corrections Technicians and 2 Community Justice Managers. Our office is located at the Mead Building in Downtown Portland.

The DV unit strives to end cycles of violence by holding individuals accountable for their actions and by giving individuals skills, resources and motivation to make positive changes.

Within the DV unit, various caseloads with specialized focuses exist, including an 'under 25-year-old caseload,' a caseload for Spanish-speaking individuals, a Reduced Supervision/Low-Risk caseload, a Deferred Sentencing (DSP) caseload and a High Risk for Lethality (DVRT) caseload. The DV unit also collaborates with a wide array of service providers who specialize in working with diverse

populations in a culturally responsive and culturally specific manner. Our officers utilize evidence-based practices including specialized assessment tools and cognitive behavioral intervention programming that is proven to reduce intimate partner violence.

In addition to working with individuals to address behavior change, Parole-Probation Officers (PPO) in the DV unit work closely with victims/survivors and DCJ Victim Advocates to develop safety plans.

# Internship Description & Responsibilities:

Many individuals placed on community supervision better themselves, reunite with their families and go on to lead healthy, productive lives.

Some individuals re-victimize, refuse to avail themselves to programs and find themselves with warrants. As a DV Unit College to County Intern, you will work with Parole and Probation Officers to motivate individuals on supervision to make positive behavior changes and work towards keeping DV survivors safe.

- Identify the whereabouts of individuals on warrant status by, contacting community providers, searching social media, speaking with victims/survivors, utilizing government databases and by being curious, tenacious and creative
- Co-facilitate Cognitive Behavioral Therapy (CBT) groups with trained Case Managers
- Utilize Motivational Interviewing to help individuals move towards positive change
- Monitor jail calls made by individuals on supervision for domestic violence offenses.

## Learning Outcomes:

- Become proficient in utilizing government databases while investigating
- Understand the various roles of staff working in community corrections
- Learn to approach public safety with a victim centered approach
- Identify Criminogenic Needs and learn to target them with interventions.

• Become proficient in using Motivational Interviewing technique
