### **Report Organization**

The Your County, Your Choice: 2009 report is organized into several major sections. It begins with summary of the major findings. Next, is a description of the study goals, methodologies, and respondent demographics. This is followed by two assessments of how County residents feel about their community, an exercise that asked residents to build a mock city budget, and results from the MaxDiff online survey.

The Your County, Your Choice research measured detailed information about six service areas: 1) parks and recreation, 2) health and human services, 3) business and the economy, 4) transportation, 5) neighborhood livability, and 6) public safety.

Each service area is compared to measures about what residents said is the biggest need local government officials should do something about, what are the most objectionable service changes, advice about what services to cut, and advice about what services not to cut. They are also compared to the results of the MaxDiff exercise. Relevant findings are shaded. Summary comments are at the end of each service area section.

### **Summary and Observations—Community Feelings**

- County residents feel good about their community
  - ❖ While they tend to feel better about communities closest to them, their average county rating was only 6.3 degrees lower than what they gave their neighborhood and City
  - ❖ Positive feelings toward the County tend to be higher among people who live between the river and I-205
  - ❖ Residents with the most education and highest incomes tend to rate all four parts of their community neighborhood, City, metro area, County the highest

### Summary and Observations—County's Direction

- ❖ Most (57%) County residents think the County is headed in the right direction, while 29% think it's off on the wrong track
  - ❖ These findings are similar to how County residents feel about their City's direction, with 61% right direction and 32 % wrong direction; don't knows were lower for their City (7% v. 15%)
  - ❖ The most educated and those with the highest household incomes were more likely to say the County is headed in the right direction
  - **❖** There is a gap between new and long-time County residents
    - ❖ Between 31% to 34% of those who have lived in the County longer than 10 years said the County is headed in the wrong direction, compared to 13% to 25% of those who have lived in the County fewer than 10 years

❖ The highest priorities are public safety, business and the economy, health and human services, and education

#### ❖Public safety

- ❖ Residents allocated the most money to public safety in their budget
- ❖ Slower responses to fire and medical emergencies and to crimes in progress were the two top very objectionable changes
- Preventing criminal activity with patrol and neighborhood services was the most mentioned service not to cut

- Business and the economy
  - ❖ Economic development/job creation was the second most mentioned need that local government should do something about
  - ❖ Promoting economic vitality and access to quality jobs to all was the highest priority in the MaxDiff exercise
  - ❖ Small business assistance and worker training were the two most urgent business and economy services

- Health and human services
  - ❖ These services ranked second in residents' budget allocation
  - ❖ Ensuring access to health care and human services for children and low income families was the second highest priority in the MaxDiff exercise
  - ❖ Serving vulnerable populations and providing health care were among the top five most mentioned services not to cut

- Schools and education
  - ❖ Education in general and school funding in particular were the first and third most mentioned needs local government should do something about in the next two years
    - ❖ If taken together, they would the most mentioned need local government should do something about
  - ❖ Educational programs were the second most mentioned service not to cut

### **Summary and Observations—Lower Priorities**

- ❖ Lower priorities are parks and recreation, neighborhood livability (except education and safety), and transportation
  - Parks and recreation
    - ❖ Maintaining and improving our parks, green spaces, water and air sheds ranked near the bottom of the MaxDiff exercise
    - **❖A** third said closing some neighborhood parks and only a quarter said closing community centers and pools were very objectionable service changes
    - Among parks and recreation programs, residents said children and youth recreation programs are the most urgent

### **Summary and Observations—Lower Priorities**

- Neighborhood livability
  - ❖ Neighborhood livability ranked 5<sup>th</sup> (of 6) in the build a budget exercise
  - ❖ Maintaining and improving parks, including underrepresented neighborhoods in public activities, and keeping the central city vital were the lowest three priorities in the MaxDiff exercise
  - ❖ Less attention to neighborhood traffic speeds and fewer building inspections were among the least objectionable service changes

### **Summary and Observations—Lower Priorities**

#### Transportation

- ❖ Improving and maintaining the transportation system was ranked 9<sup>th</sup> (of 12) in the MaxDiff exercise
- ❖ Transportation ranked 4<sup>th</sup> in the budget building exercise
- ❖ Increased traffic ranked towards the bottom of very objectionable service changes
- ❖ Paving and fixing potholes was the most urgent transportation issue
- ❖ Transit, transportation planning, and bridges were in a second tier of most urgent transportation services

### **Summary and Observations-Other**

- **Among services not included in the six main areas:** 
  - ❖ Closing County and City government offices five Fridays a year was the least objectionable service change
  - ❖ Maintaining a financially stable County and City ranked 3<sup>rd</sup> (of 12) in the MaxDiff exercise
  - **❖Reducing both spending/unnecessary administrative costs and government employee salaries/benefits were the top two suggestions (unaided) of what services to cut**
  - ❖ Better public leaders and manage the budget were among mentions when residents said what they thought was the biggest need local government should do something about
- ❖ While there were a variety of subgroup variations, we found nothing particularly surprising or unexpected

- ❖ Assess Multnomah County residents' feelings about their community and the County's budget priorities to inform decision making related to the budget
- ❖ Supplement information about Multnomah County residents' budget priorities gathered at public forms and through other civic engagement/public involvement techniques
- Provide a benchmark to determine changes in attitudes over time

# **Telephone Survey Methodology:**

- Completed 500 telephone interviews with County residents, scientifically and randomly conducted
- Conducted March 12–18, 2009
- Averaged 15 minutes to administer
- Quotas established for age, gender, area, and ethnicity based on the total number of residents in Multnomah County to ensure a representative sample
- Bilingual interviewers (Spanish)
- ❖ Margin of error +/- 4.0%

### MaxDiff Online Survey Methodology

# **MaxDiff Methodology:**

- MaxDiff is an approach for obtaining importance scores for multiple items. It has been shown to deliver greater discrimination among items and between respondents than the more commonly used rating scale questions.
- The reason that MaxDiff is effective is two-fold:
  - First, respondents must make trade-offs in order to choose the best and worst displayed items. They do not rate items in isolation, but in competition.
  - Second, the choices are made without the use of a scale. Scales introduce the opportunity for interpretation bias.
- Importance scores show relative strength for 12 items converted to a 100 point scale with an average score of 8.3
- Supplement to the telephone survey
- Completed 250 interviews online using a professionally maintained panel of Multnomah County residents
- Quotas established for age and gender based on the total population of Multnomah County to ensure a representative sample




### **Community Feelings by Gender**




### Community Feelings by Age




### Community Feelings by Income




### Community Feelings by Area of Residence




### Community Feelings by Time Lived in the County









## Parks and Recreation—Summary

- **❖Parks and recreation services are a relatively low priority:** 
  - ❖ Neighborhood livability ranked 5<sup>th</sup> (of 6) on the "build a budget" exercise
  - ❖ Maintaining and improving parks ranked 10<sup>th</sup> (out of 12) on the MaxDiff exercise
  - ❖ A third said closing some neighborhood parks and only a quarter said closing community centers and pools were very objectionable service changes
  - ❖ Several parks and recreation services were offered by residents as possible cuts, including community programs and maintaining neighborhood parks, arts and culture, and bicycle paths
  - ❖ No issue directly related to parks and recreation received more than 2% of responses to the "biggest need" question

## Parks and Recreation—Summary

- **❖Among park and recreation services:** 
  - ❖ Residents prioritized children and youth recreation programs as most urgent
  - ❖ Maintaining natural resources and open spaces and neighborhood parks were in a second tier of most urgent services
  - ❖ None said adult recreation programs are most urgent and just 4% said senior recreation programs are
  - ❖ Children/youth programs were most urgent to residents living east of I-205 (compared to between the river and east) and longest term residents compared to those of 6-10 years; the youngest residents more often said natural resources and open spaces were most urgent



#### One biggest need local government should do something about:

"Health care. Making it more affordable for everyone."

"Fix our health care and homeless problem. I think health care should be more affordable especially for children."

"Increase access to social services, because economy being the way it is, more and more people are needing help, and the city should be able to provide it."

"They need to do something about the homeless people. There is a large problem here but there needs to be employment to help."

## Health and Human Services—Summary

- Health and human services are a high priority:
  - ❖ Residents ranked these services second in the "build a budget" exercise
  - ❖ Ensuring health care and other human services for children and low income families ranked 2<sup>nd</sup> (of 12) in the MaxDiff exercise; ensuring affordable housing and services for seniors and the disabled ranked in the top half
  - ❖ Half said reduced availability of health care for children and low income families was a very objectionable service change
  - ❖ 30% to 42% said reducing services in six other areas was very objectionable: battered women, at risk youth, the elderly and disabled, people with mental illnesses, low income housing, and services for the homeless and low income residents

## Health and Human Services—Summary

- ❖ Services to vulnerable populations and programs that provide health care were in the top five services of what not to cut
- ❖ Services support affordable housing was mentioned by only 2% as a possible cut; no other health and human service was mentioned more often
- Among health and human services:
  - Residents prioritized providing health care and serving vulnerable populations as most urgent
  - ❖ Supporting affordable housing and reducing homelessness was in a second tier of most urgent
  - ❖ Providing health care was more urgent to part-time workers; supporting affordable housing and reducing homelessness was more urgent to the lowest (v. highest) income





#### One biggest need local government should do something about:

"Well I think they need to do a lot of work on the streets, especially side streets, because they have pot holes and when we have snow storms they give us a lot of problems."

"They need to do something about the roads in our area; there are just too many potholes."

"I would say improvements to public transportation. I just received notice that Tri-Met is thinking about cutting transit, and it's not good because with the current state of the economy we are in need of this source of transit."

# **Transportation—Summary**

- **❖** Transportation is a mid-level priority:
  - ❖ Transportation ranked 4<sup>th</sup> (of 6) in the "build a budget" exercise
  - ❖ Building a livable city/county through good planning ranked 8th and improving and maintaining the transportation system ranked 9<sup>th</sup> (of 12) in the MaxDiff exercise
  - ❖ Just 20% said increased traffic congestion and less planning for growth were very objectionable, and only 17% said less attention to neighborhood traffic speeds was very objectionable
  - ❖ Transportation planning was the 3<sup>rd</sup> most frequently mentioned service to cut at 6%; a smaller number (3%) said NOT to cut this service

  - **❖**Paving and potholes was the most urgent by a notable margin
  - ❖ Second tier transportation service needs were transit, transportation planning, and bridges



#### Neighborhood Livability—Comments

#### One biggest need local government should do something about:

"Education, school funding and programs for kids. I don't have any [kids] but I think the education program sucks. Education across the board is in ruins. The cuts in arts, health education and extra curricular activities will produce really dumb kids."

"Schooling. I mean high school, and all areas of schooling should be covered. Don't drop PE, music, or any classes because of cost."

"Prioritize education. Increase and secure definite revenue sources."

"Something about the fact that there are no city codes here like in other cities and people have trashy stuff all over the place."

"I think the cleanliness, specifically the litter and graffiti."

#### **Neighborhood Livability—Comments**

#### Advice about what to cut:

"Any new stuff. New tennis courts or pools. It's an unbalanced priority."

"I think that helping clean the parks is not very critical right now. To have some open and close at certain times and the energy sources they use to keep the parks clean, I just don't think that it's critical at this time."

"I guess the first thing I would cut would the office of neighborhood involvement because I don't see it as a very effective service."

#### **Advice about what NOT to cut:**

"We have to take care of our kids and they could increase volunteerism in the community to give the kids and adults something to do."

"Arts. Arts are the glue that keeps the community and people together."

"There are very limited outreach/efforts to keep the people in touch. They're working in the dark pretty much. It would help if they had vehicles to get the word out."

## **Neighborhood Livability—Summary**

- ❖ Neighborhood livability is a high priority when related to schools and safety:
  - ❖ Schools and funding were the 1<sup>st</sup> and 3<sup>rd</sup> biggest needs residents said local government should do something about
  - ❖ Educational programs/expenses ranked as the 2<sup>nd</sup> highest service NOT to cut; preventing criminal activity with patrol and neighborhood services was the top service NOT to cut
  - ❖ Ensuring a safe and peaceful community ranked 4<sup>th</sup> in the MaxDiff exercise
- **❖** Other issues are of relatively lower priority:
  - ❖ Neighborhood livability ranked 5<sup>th</sup> (of 6) in the "build a budget" exercise
  - ❖ Less attention to neighborhood traffic speeds and fewer building inspections were among the least objectionable service changes

#### Neighborhood Livability—Summary

- ❖ Maintaining and improving parks, promoting inclusion of underrepresented neighborhoods and groups in public activities, and keeping a vital central city were the last three ranked services in the MaxDiff exercise
- Among neighborhood livability issues:
  - Supporting children's educational success was the most urgent;
  - ❖ Open spaces, parks and recreation, and library services were second tier issues
  - ❖ None said arts and culture and animal control were most urgent
  - ❖ Community involvement was most urgent to just 8%, with a higher response among West residents



#### **Public Safety—Comments**

#### One biggest need local government should do something about:

"Probably the best thing to do would be to work on safety and security. There is so little police presence and so little support for the firefighters."

"Safety and crime, particularly downtown. Make people feel safer in the city."

"Crime, it's the city's fault. The city doesn't have enough police to handle the crime."

"More neighborhood patrols, especially in the St. Johns area. They should definitely not close the St. Johns north precinct, it should remain open."

"Gang related activities, including drugs and graffiti."

"Gang violence, because it seems to be on the rise."

"Crime. In my neighborhood cars are getting broken into, graffiti is everywhere and there are no cops."

"Increase jail beds. They're closing down and there's no place to put criminals."

#### **Public Safety—Comments**

#### Advice about what to cut:

"I would say cut the budget for the detention centers and jails and dump that money into schools."

"Jails should find things to do with convicts. A better juvenile system that could find something to do for the juvenile convicts."

"The money that they're trying to spend on prisons needs to go to education, atrisk youth, or rehabilitation."

"Let the operating days for the courts go from five to four day [weeks]."

"Maybe the parking enforcement and stuff like that."

"Get rid of the vice squad and the pursuit of victimless crimes like prostitution."

#### **Public Safety—Comments**

#### **Advice about what NOT to cut:**

"Cutting back on police and fire will not solve the shortfall problem."

"Jails, because we can't let the people who do wrong on the streets do more wrong."

"The undercover drug taskforce that helps protect the city from drugs and violence. If they cut that, the drug dealers will run rampant."

"Gang enforcement, because we have a serious gang problem in this city, especially in schools."

"Don't cut the drug rehab and detox services."

"Public safety is a primary responsibility of the government, but also other things like drug and alcohol treatment and preventative measures."

"Drug court should not be cut. Do not get rid of the Multnomah County Drug Court."

"Don't cut funding for transitional housing for the Department of Community Justice. Particularly the program that helps women coming out of prisons."

#### **Public Safety—Summary**

- **❖** Public safety is a high priority:
  - ❖ Public safety was the top spending priority in the "build a budget" exercise; longer term residents and those East of I-205 gave it even higher priority
  - ❖ Crime/jail space was the 4<sup>th</sup> most mentioned need that local government should do something about in the next two years
  - ❖ Ensuring a safe and peaceful community ranked 4<sup>th</sup> (of 12) on the MaxDiff exercise
  - ❖ Slower response to fires and medical emergencies and to crimes in progress were the top two "very objectionable" service changes
  - ❖ Nearly a third said changing services in four other areas was very objectionable: reducing at risk youth programs, fewer criminal investigations, reduced support for mentally ill and addicts, and smaller police presence in neighborhoods

## Public Safety—Summary

- Among public safety services:
  - ❖Two of the most urgent service needs were: 1) gang related crimes, and 2) enforcing the law including gang, drug crimes, and person and property crimes
  - ❖ Preventing criminal activity with patrol and neighborhood services was the top service NOT to cut
  - ❖ Family services to juvenile offenders, alternatives sanctions, mental health treatment for offenders, and person crimes were in a second tier of most urgent
  - ❖ In the open ended comments, residents expressed concern about increased crime in general and gang crime in particular, not enough jail beds, and the link between increased crime and jobs/economy
  - ❖ Residents felt preventing person crimes was more urgent than property crimes and neighborhood livability issues; person crimes were most urgent to the newest residents
