




* The 677 paid bed days in December 2008 represent a total of 70 hospital discharges.


Notes: WIC visits continues a two-month decline, driven mainly by a decrease in visits for women. Health clinic visits and average daily visits is back to normal after a significant decrease in November and December, mainly for insured visits. Mental health crisis calls leveled out after a 26% decline in December. ADS helpline calls have been rising steadily since May 2008. Verity information is not available for January 2009. OHP data is still not available due to a data system change in December. Crisis calls were up significantly after a December decrease.



Protective Services for Vulnerable Populations




*Each program serves different populations. ADS is responsible for all protective investigations not covered by developmental disability and mental health services, so they have the largest client base.



*Overall, 287 protective service investigation cases opened and 261 allegations closed in January 2009. Of those closed, 34% were substantiated (n=89). MH 'not substantiated' cases include those that didn't meet the abuse definition.




months. The monthly data will change slightly with each new update.

* Of 661 treatment episodes ending in June 2008, 55% (n=365) successfully completed programs, 32% (n=211) failed to complete, and 13% (n=85) had neutral terminations. All closed cases, no matter how they exited from treatments, were included in the denominator for calculating completion rates.

Notes: Mental Health clients have decreased significantly since October. Developmental Disability clients have continued to rise steadily this month. Rental and housing clients fell significantly in January after a significant rise in December, driven mainly by a 50% decline in Youth Shelter clients. Rental assistance since July 2008 includes domestic violence clients as well as family and disabled. Rental assistance has risen steadily in the last two years from 55 clients in January 2007 to 154 clients in January 2009, although slightly down from a high in December 2008.
