Definitions

- School-Based
 - Services housed and primarily delivered at a school site. The primary recipients of the services are the students enrolled in the school and the community immediately adjacent to the school.
- School-Linked
 - Services housed at sites other than schools. These services are delivered at various community sites, which may include schools.

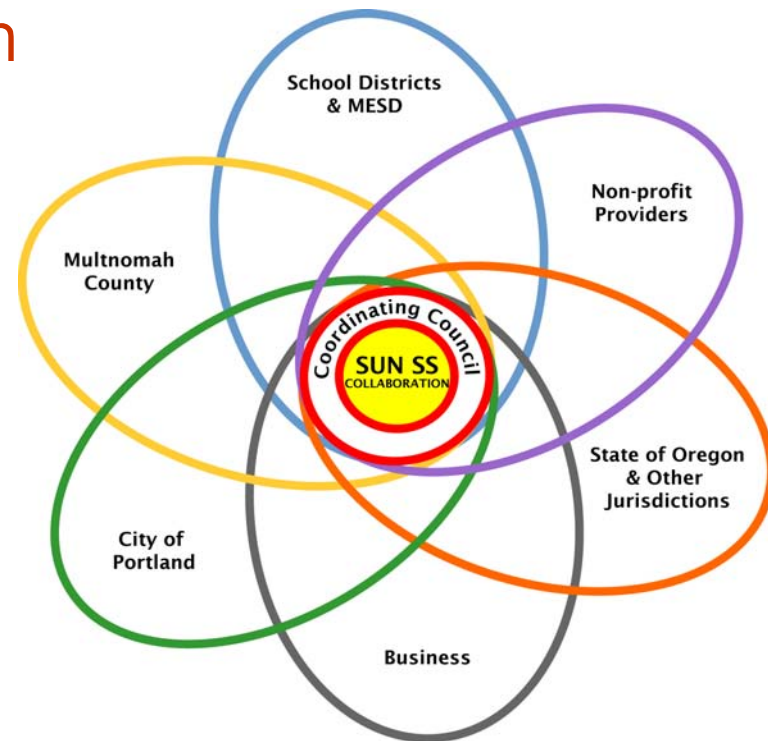
Core Services Recommendations

Allocation Methodology Recommendations

- Allocation Principles
 - Maintain the existing allocation formula for culturally specific (target outreach population) services
 - Beyond this, allocate resources based primarily on poverty
 - Ensure a base level of service geographically spread across the county for both school-based and school-linked services

Building a Brighter Future for Our Kids and Families

Allocation Methodology Recommendations

- School-Based Services
 - Allocate a base level of resources in all high school catchments where the high school is in the top three quartiles of the Poverty Index
 - Shift resources from currently operating sites in the 3rd and 4th quartiles of the poverty index by reducing funding or relocating services

Building a Brighter Future for Our Kids and Families

Allocation Methodology Recommendations

- School-Linked Services
 - Allocate services in the six existing SUN service regions based on the percentage of the target population for the service that resides in the region
 - Obtain Census projections for current level of target populations residing in each region from a qualified consultant
 - If the funding level for a region falls below a reasonable “base amount,” consider contracting with fewer providers to offer services over a larger geographic area
