19. **DECLARATION:**

A. Verify Owners — Signatures in permanent black ink.

B. Notarized — If an Oregon Notary — Notary signature, full printed name, Commission No. and Expiration date (Month by name [not abbreviated], two-digit date and complete year — i.e. January 03, 2002) in permanent black ink.

C. If out of state notary, must have legible stamp and signature in permanent black ink.

D. State "the declarant has caused the partition plat to be prepared and the property partitioned in accordance with the provisions of ORS chapter 92".

E. Any dedication of land for public purposes or any public or private easements created, or any other restriction made must be stated in the declaration.

F. Consent affidavit if others (Trust Deed Beneficiaries, Mortgage Holders, or Contract Vendors) having an interest in the property platted only if there is dedication of land for public purposes. (i.e. Public easements, Street dedication, etc.)

20. SURVEYOR'S CERTIFICATE:

A. Statement to the effect that the surveyor "<u>has correctly surveyed and marked with proper</u> monuments the land as represented".

B. Has placed or found a proper monument as provided in ORS 92.060 indicating the initial point of the plat, and giving the dimensions and kind of monument (a complete description). Must be a held monument without fallings.

C. Location of Initial point in accordance with ORS 92.060 (by survey to a monumented section corner, 1/4 corner, 1/16 corner, DLC corner, lot, parcel or boundary corner of a recorded subdivision, partition or condominium plat.)

D. Accurately describing the tract upon which the tracts and parcels are laid out. Adequate boundary calls. Location by ¼ section/Township/Range/City/County/State. Bearings & distances conform to drawing.

- 21. **APPROVALS:** City/County planning; City/County engineer(if applicable); County Surveyor; Assessor's statement; and Recorders statement; See Partition Approval form. See "Public Road Dedication by Partition Plat" on web site for specific dedication acceptance language by jurisdiction.
- 22. **PARCEL NUMBERS Parcel** number for partitions in Arabic numerals (no roman numerals). Tracts identified by letter designation.

23. BOUNDARY RESOLUTION:

- A. Must meet all the requirements of a survey per ORS 209.250

- A. Boundary/Parcel/Tract closure.
- B. Street/Easement closure.
- C. Area of Parcels and Tracts (Square feet or hundredth of an acre).
- D. All individual distances need to add up to totals shown

25. EASEMENTS:

- A. Purposes & record information
- B. Width. State beneficiary if "private". Label "public" or "private". Term if necessary.
