## **Group Check in and Announcements: One Small Success**

Steering Committee members and attendees began by each sharing "one small success" – something in their work or life that has gone well recently.

#### **STRYVE**

Rebecca Stavenjord and Samantha Kaan provided an update on the STRYVE coalition capacity assessment survey results. Comments raised some confusion about the audience and intent of the survey, and this led to a discussion of the role of the Youth & Gang Violence Steering Committee in the STRYVE project. Rebecca explained that the granting agency, the Center for Disease Control and Prevention, provided the survey questions and all STRYVE sites will respond to the same surveys over the period of the project. Roberta said she would follow up to the discussion by working with Rebecca to bring a proposal to the Steering Committee clarifying the roles and functions.

#### **Robert Ingram Youth Summit Against Violence**

Rikayah Johnson provided an overview of the recent Rob Ingram Youth Summit Against Violence. The Multnomah Youth Commission voted on policy recommendations at the summit. A draft of those policy recommendations can be found here:
