	The community questioned why there is nothing in place to ensure the community is safe in regards to juveniles carrying guns? There are county programs currently in place to address these issues but they are not getting the job done - the community observes youth with gun charges being released into their communities. They state programs need to be preventive and not "after the fact" reactionary.	
	Some of these troubled youth are identified early in the system - what type of supports are put in place for these vulnerable families prior to a youth offending? Suggested to reinvent relationships between communities, cultures, races, etc establish a cultural community center to begin bringing these groups together. To be effective, we need to partner with:
