### **MEETING MINUTES**

#### **Welcome and Introductions**

Cover Oregon  Josie Silverman Antonio Torres	There are about 1.3million uninsured veterans in the US, with around 63,000 uninsured veterans and their family members in Oregon. Estimate that about ½ of them will qualify for Medicaid, and many of those who don't will qualify for a subsidy on the health insurance exchange. Goal of the presentation is to improve outreach to uninsured veterans in Multnomah County for health care services (in addition to other benefits they are eligible for).  Open enrollment through Cover Oregon started in October and ends 3/31/14. Next open enrollment period will be in the fall. The OHP Medicaid expansion is open year round. Plans are available to be compared at coveroregon.com, and it is recommended to use the google chrome browser. Tax breaks often decrease the premium amount. The portal to sign up is currently only accessible by trained assisters, whose contact info is available on the site.  A homeless veteran would likely qualify for Medicaid, and there are many assisters at the county as well as about 20 trained to assist at Central City Concern. Cover Oregon's application screens for both Medicaid and eligibility for all other plans.  Commissioner McKeel led discussion about making a formal request to Cover Oregon, likely through the Association of Oregon Counties (AOC), to add a question to application form asking about military experience, and explore release of info to assess VA eligibility.	To be trained as an assister, contact communitypartner@coveroregon.com  Will look into possibility of training CVSOs on assisting or available resources/referrals to connect a vet with health insurance.  Increased Cover Oregon involvement in veterans events (such as Yellow Ribbon pre/post deployment, job fair in Salem this March, maybe vet-focused application fair)
