Introductions, Announcements, and Approval of Minutes

LPSCC Co-Chair, Commissioner Shiprack called the meeting to order.

The minutes of the February 4th, 2014 LPSCC Executive Meeting were approved.

Due to the July 4th holiday, July's LPSCC Executive Committee meeting will be held on Tuesday, July 8, 2014.

The What Works Conference is tentatively scheduled for Friday, January 9th, 2015.

Judge Waller announced that eCourt implementation is less than 40 days away. Odyssey orientations are listed on the Court's website.

Representative Williamson gave a legislative update. Highlights of public safety budgets included:

- In 2013, 2% of agency budgets were held back. Most agencies will receive a portion of the 2%. Dept. of Corrections and Community Corrections both received full 2%.
- There was no change to the day-rate reimbursement policy.
- A [pre-adjudication private health insurance](#) measure was passed.
- Debt-servicing a new courthouse from uncollected class-action judgments was passed in the House but not in the Senate.

There was also momentum around issue of funding for capital improvements and construction of courthouses.

LPSCC Executive Director Abbey Stamp highlighted some of the outcomes from the March LPSCC retreat, which focused on how to best use the 15 meeting hours a year:

- LPSCC Committee Meeting agenda items will have a “so-what” component
- LPSCC will be creating a presentation request form
- LPSCC will be developing a newsletter
- LPSCC subcommittees will report to executive committee on a quarterly basis and updates will include a deeper discussion of the subcommittee work
- The Public Safety Trends Report will be a recurring talking point at future meetings.

Information Sharing Proposal

PPB Commander Kevin Modica, along with DCJ’s Deena Corso, presented on the subject of information sharing. Refer to the *Information Sharing Proposal to LPSCC Executive Committee* presentation for more information about the importance of information sharing, what information sharing is and what it is not. Requests were made of the executive committee:

- 1) To endorse an information sharing policy
- 2) For the LPSCC executive committee to act as the key convener
- 3) To endorse and expand membership of the Information Sharing ad hoc Workgroup
- 4) To assist in identifying a point person for each needed MOU
- 5) Support and provide resources to develop and implement MOUs

Action Items: The executive committee adopted the requests outlined during the Information Sharing Proposal and approved working with the Gang Impacted Family Team (GIFT) and STRYVE to pilot the development and implementation of information sharing MOUs. LPSCC will also create and maintain a library of MOUs.

May 6th Meeting

It was suggested that LPSCC discuss and clarify authority for the removal of firearms from a restraining order respondent. A federal representative should be present.
