Executive Summary

The development of Maternal Medical Home teams in Health Department primary care clinics would support the integration of public health and primary care services and programs to enhance the service and support we provide to the 1200 births we see each year in our clinics. The development of this team would ensure that we provide a wraparound approach to serve pregnant women and families through the integration of home-based services, the addition of culturally specific support services, and comprehensive coordination to keep families engaged in our primary care.

Program Summary

In the past year, Early Childhood Services, Integrated Clinical Services, and other County programs that support families have been developing the concept of a Maternal Medical Home (MMH). The goal of the MMH is to ensure that families assigned to Multnomah County as their primary care provider receive the maximum benefit from our family-focused programs, and to ensure that we are providing additional support to families that have more intensive medical and social risks. We know that early support for families across multiple health issues is needed to set the stage for lifelong health. Adding staffing to support the development of a MMH will allow us to bring the expertise of Early Childhood Services and other programs in to the clinical setting to support families. This concept is not unique in health care; regionally other primary care systems have developed similar models to support prenatal and postpartum health that go beyond clinical care to understanding the importance of additional support that may be needed to set the stage for lifelong health.

The full MMH team would include the addition of five new staff and support two existing staff. The team will consist of two Community Health Nurses, three Community Health Workers, one data analyst and one project coordinator.

The focus areas of the MMH include developing clinical and home based systems to provide early prenatal risk assessments, comprehensive care management from prenatal care through delivery, enhanced breastfeeding support, enhanced prenatal tobacco cessation support, comprehensive family planning, developmental screening for children, and coordination to ensure nutritional support and screening.
