Introductions, Announcements, and Approval of Minutes

Commissioner Judy Shiprack called the meeting to order and introductions were made.

Commissioner Shiprack introduced Lincoln County Commissioner, Bill Hall, who will be president of AOC.

The minutes of the July meeting were approved.

- Judge Waller announced there will be a procedural fairness assessment that will lead
 to recommendations. There will be a one week survey at the four courthouses to get
 a baseline of people coming into court.
- The board briefing for Justice Reinvestment budget amendments will be September 22nd. The budget modification will be October 8th.
- The next LPSCC meeting will be September 29th instead of October 6th.

- Rod Underhill noted the District Attorney's Office and the Portland Police Bureau are seeking funding for Safe Kits. They submitted a BJA grant and a DANY grant. Recipients of grants will be announced on September 10th.
- Judge Frantz noted the eligibility criteria for Veterans Court is expanding to some domestic violence crimes.
- Suzanne Hayden mentioned the Veterans Stand Down on September 11th at the Veterans Memorial. Resources and benefits will be provided to homeless vets and returning National Guard members. If people are going to take advantage of the justice table to look at charges, they have to get there before noon.
- Annie Neal noted there will be a Domestic Violence Awareness Vigil in Gresham on October 6th. Details will be forthcoming.
- Judge Waller noted MCJRP is looking at how to integrate specialty courts based on risk rather than charge.

Multnomah County Community Corrections Plan

Department of Community Justice (DCJ) Director, Scott Taylor, presented the Multnomah County Community Corrections Plan. Protocol requires LPSCC to approve the Community Corrections Plan. DCJ is funded through the County, Department of Corrections, and the Criminal Justice Commission. The two-year plan outlines how felons will be supervised in the community and how locally sanctioned individuals will be managed. Highlights include: reassessing work with crime victims; treatment readiness (with the Sheriff's Office); changes to the resource center; working on use of jail and alternatives for those with mental illness; examining DJC's role in reducing racial and ethnic disparities; increasing capacity as more people have access to healthcare; hiring new probation officers. Jeremiah Stromberg of DOC noted the plan meets the statute requirements and keeps its focus on the felony population. He recommends it be approved.

The plan was adopted by LPSCC.

Juvenile Justice: A National Perspective

Commissioner Shiprack noted the increasing national focus on juvenile justice and made the following comments:

- Multnomah County has a strong history with positive results. For example:
 - Work with STRYVE, Youth and Gang Violence
 - School based health clinics now emphasize behavioral health and have relationship with families from K-8.
 - In the area of Racial and Ethnic Disparities, the county is working CHI
 early intervention capstone project, and has had two What Works
 Conferences with this focus. There will be a meeting with retail loss
 prevention to talk about their role in entry into the criminal justice system.
- National Association of Counties (NACo) is starting to focus on juvenile justice.
 Commissioner Shiprack is chairing the NACo 's subcommittee and juvenile justice. She asked for help with the opportunity to impact NACo's focus.

There will updates on LPSCC subcommittee work at upcoming LPSCC meetings.

Scott Taylor noted research and presentations on brain development and our understanding of the juvenile brain.

Judge Waller requested a NACo level presentation with work going on at OYA.

Marijuana and Public Safety

Multnomah County Health Official Dr. Paul Lewis gave an overview of legal retail marijuana that included rationales for legalization, the public health approach and priorities, current marijuana use, possible health effects, OLCC rule making, on-going policy issues, House Bill 3400 and other related bills. Portland Police Chief Larry O'Dea added challenges law enforcement face:

- Traffic fatalities--there's been a sharp increase in Colorado
- Processing an impacted driver on marijuana and testing levels of intoxication
- Edibles pose a higher overdose risk. Public health messages are needed
- Residential robberies around medical marijuana
- Livability issues
- Access to children at a younger age and the debate over whether it is a gateway drug.

District Attorney Rod Underhill added what he's learned from Denver and Seattle:

- Increase in business robberies
- Underground market will still be an issue because it is untaxed/cheaper
- Pets are consuming edibles.

Lane Borg added he hopes rigorous science will be applied.

Commissioner Bailey is interested around penalties and enforcement around children.

The meeting was adjourned.
