Introductions and Announcements


Antoinette Edwards opened the meeting and introductions were made.

- The "Enough is Enough" event was featured in the Skanner on August 5th.
- The District Attorney's Office has hired a dedicated research data analyst, Ralph Holcomb.
- The new lead investigator with the DA's Office is Paul Weatheroy
- <u>The Portland Tribune</u> recently featured STRYVE as an approach to tackling gang violence.

1. Geographic area(s) of focus: Coordinating Council's Recommendation

The Coordinating Council identified two geographic focus areas: Portsmouth and a belt north of the Springwater Corridor that is still being defined. The risk factors map was displayed to show the areas with greatest need.

The subcommittee approved the geographic focus areas.

2. Gang Designation Policy Review Process

Assistant Chief Kevin Modica showed the <u>policy directives</u> on the Portland Police Bureau website and noted there would be workgroups created to give feedback to the proposed directives related to gang affiliation.

3. Strategies #1 and #4.

The Coordinating Council had refined the two strategies, and the subcommittee was asked to discuss and approve.

#1 Coordinated Entry

Discussion: Rod Underhill asked the question: does violence mean all violence and include DV, child abuse, etc? The answer was yes. Is everyone at the table that needs to be? Erin Fairchild can help reach out to partners. There needs to be someone working on human trafficking. It was suggested that paternal not be left out of the footnote. Rockwood Pathways Initiative could be called out as an example.

The strategy was approved.

#4 Connection to Schools

Activities related to the strategy were discussed:

- Have a yearly or semi-yearly meeting with the MOU group.
- DCI is addressing Trauma Informed Care within Reynolds School District. They will be using the Breakthrough series to address intractable problems.
- It was suggested to align ourselves with the Chair's efforts within schools.
- It was noted that DHS is working with schools to communicate when a child has been taken into protective custody.
- It was asked whether it's realistic to work with all the school districts in our target location.
 Rebecca noted that east county has monthly meetings and that we need to go to the school meetings.

Word-smithing

- It was suggested to change wording to "young people with risk factors" rather than "at-risk, gang involved youth". It was later suggested to change to "examine and develop shared recommendations." Use "young people vulnerable to risk factors and gang . . ."
- Should strategies be changed to practices?

Roberta will incorporate the changes and bring to coordinating council and then back to the subcommittee.
