Executive Summary

A Home for Everyone (AHFE) is a joint jurisdictional initiative addressing homelessness in the county. AHFE includes emergency homeless services such as Safety Off the Street, Emergency Shelter and Housing Placement for families and unaccompanied youth experiencing homelessness.

Program Summary

This program consolidates portions of other Program Offers to align all homeless services under the A Home for Everyone umbrella. Other ongoing funds will be aligned with the target populations and priority programs determined by the AHFE executive board, including rent assistance, safety off the streets, outreach and housing placement.

The Homeless Families System of Care (HFSC) provides safety off the street, emergency services, housing placement and short-term rental subsidies for families with children who are experiencing homelessness. The system leverages a variety of federal, state and local resources, as well as faith-based and non-profit partnerships. Last year 500 households were served in our no turnaway shelter, 500 households were assisted by the Mobile Housing Team and nearly 400 were housed with HFSC funds. Just over 95% of households placed by this team were still stably housed 6 months after assistance ended.

The Homeless Youth System (HYS) provides 24/7 crisis and safety services utilizing assertive engagement and positive youth engagement; emergency shelter, transitional Housing and permanent housing placement; physical and behavioral health linkages, education and employment training and support, specialized services for pregnant and parenting teens for homeless youth. Over 1,800 homeless youth are served annually.

The Domestic Violence emergency shelter system provides secure, confidential locations for immediate safety and support for those who are fleeing domestic violence. Services include: basic needs, safety planning, specialized children's services, advocacy and access to other services. An average of 33 households are served in three shelters each night.

Flex Funds for Veterans helps homeless veterans leverage federal housing resources such as VASH and SVFF by providing housing search assistance, funds for deposits and move-in assistance. This program offer also includes funds targeted by AHFE for the City of Gresham to support: homeless outreach, housing placement, camp clean-ups and additional shelter capacity for homeless singles and couples in Gresham and the eastern parts of Multnomah County.
