Introductions, Announcements, and Approval of Minutes

Introductions were made.

The May LPSCC minutes were approved.

Announcements:

- Rose Bak announced the county is funding a new domestic violence advocate for seniors, and that position has been filled. Referrals are now being accepted.
- Truls Neal noted DCJ's female units are now strategically located in Gresham.

Extreme Risk Protection Order (ERPO)

Judge Stephen Bushong reviewed the statewide status of judicial filings and rulings on Extreme Risk Protection Orders (ERPO) from January - June 2018. He highlighted a few numbers:

- 43 ERPOs statewide have been filed, 9 in Multnomah County.
- Most ERPOs have been sought by law enforcement.

Charles Sparks, Chief Deputy District Attorney, introduced the <u>ERPO flyer</u> the ERPO workgroup created with County Communications. Law Enforcement and other partners participated.

The District Attorney's office is ready to handle violations.

Assessment and Recovery Community Housing (ARCH 1) Program

Neal Rotman, Health Department and John Karp-Evans, Central City Concern, presented information about the new transitional housing program *Assessment and Recovery Community Housing (ARCH 1)*. ARCH fills a housing gap and is a brief stay (1-3 months) transitional housing program that provides stabilization services that support houseless individuals in mental health recovery. For information about the renovation, services, population served, and collaboration, see the presentation.

Neal would like to come back to LPSCC in a few months to share the data.

LPSCC-Related Work Updates

Abbey Stamp gave an overview of the work LPSCC is doing, including site visits, national meetings, the Youth and Gang Violence subcommittee work, research projects, and Safety and Justice Challenge strategies.

Sarah Mullen talked about the Law Enforcement Assisted Diversion (LEAD) expansion. At the time of the meeting, there were 113 referrals and 89 active participants. There will be a Seattle LEAD site visit for staff this summer.

The Diane Wade House (formerly SJC Women's Program) will likely launch this fall. Positions are being developed and hired. Michelle Aguilar, DCJ, noted the program is named for <u>Diane Wade</u>, an African American Probation Officer who ran a program for African American women. Michelle is leading an advisory board that includes peers.

Abbey ended with the note that the What Works Conference will be held during the next legislative session and will present facts about what types of behavioral health treatment and approaches are best for justice-involved populations.
