Guests: Jody Michaelson, Transition & Diversion Mark Nishi- Strattner, Public	Discuss client choice in ADVSD programs	Betty Cox	Jody introduced Miriam who was an intern with the college to work program and now is temping with the county this summer. Gave a bit of info about that program. Jody is the program manager for Transition and Diversion at the county. This program serves the persons who land in nursing homes in Multnomah County. Their job is to help with the transition into and out of nursing

facilities. They also have the option to stay in the nursing facilities. They explain and help them make those decisions. Choice and safety are the big things they look at. They coordinate moves for about 45-50 folks a month. They help with ramps, rails, etc. in homes when needed. 30% of their clients go home, and they can help with setup of Home Care Workers. 24% of the clients never need help again. 10% go into assisted living or other care facilities. 20% of the client's move into Adult Care Homes which house up to 5 clients in private homes. This program works very hard to get folks into the living situation they want. Special needs homes are also available (weight, Parkinson, neurological etc.). This is a Medicaid service. They also refer when appropriate. Bill commented that it would be nice to put more about this program on ARDC website. The 3 links below are great resources for this program:

Jody says she wants to make sure folks are advocates for themselves. She

wants to makes sure that we seek out any services available to help. Jody is also very open to feedback for improvement. There was a question to Jody about rules changing for adult care homes, she does not work in the department that deals with this. She thinks that they are taking the safety and needs of these clients very seriously.

She also said they can refer ove- income people to other agencies when needed. Jody also told us they get the contractors for work in homes through vetted people through the state.

Mark is a Program Supervisor for Public Guardian & Conservator Program that serves adults in Multnomah County. You do not do not have to be a client of DCHS to qualify for this program. Referrals come from Case Managers, hospitals, families etc. Funding comes from a general fund for the county. The focus is on folks who do not have the money to pay for this service and have no family to do this for them.

Criteria: Cognitively incapacitated and a judge makes this decision. At this time about 160 clients are being served in this program. They are usually served for the rest of their lives. There are about 20-25 new cases petitioned each year. There are many reasons why these clients need to be served. Court grants the public guardian the rights to make health care decisions, where they live and how to structure finances. The public guardian needs to know their clients so they can make the best decisions for them. They must take into account religious, cultural, background etc. before making decisions. If the clients are able, they are involved in these decisions. The public guardians are nationally certified. There are

			volunteers that help with shopping, visits, etc. At this time there are 7 guardians who can make decisions. They have a case load of about 35 clients. There is always someone on call. 5 deputies run all the cases. If there are medical decisions to be made they involve family, doctors, and ethics consults if needed. Mark wants us to know they serve very vulnerable people. These people need our help and protection. He believe public guardian is a valuable service. Mark also told us when a private fiduciary is paid the fees must be approved by the court. Marks unit also has a holiday event where they deliver gifts to their client.
