



- (A) General standards for all response activities.
  - (1) Following emergency/disaster response actions, best management practices (BMPs) to prevent sedimentation and provide erosion control shall be utilized whenever disaster response actions necessitate vegetation removal, excavation, and/or grading. BMPs may include but are not limited to: use of straw bales, slash windrows, filter fabric fences, sandbags, straw cover, jute netting, etc.
  - (2) Structures or development installed or erected for a temporary use (e.g. sandbags, check dams, plastic sheeting, chain link fences, debris walls, etc.) shall be removed within one year following an emergency event. Thank you for the additional information I have sent notice to USFS, ODFW, SHPO, and the Tribes. It is likely they will contact Dan and Kent directly if they have concerns, in the event they reach out to me I will send them to Dan or Kent.

The County is obligated to review our natural resource inventory data and notify ODOT regarding the resources and associated buffers. I have attached our inventory maps for the area and have listed the resources below along with their corresponding buffers:

#### NSA Wetlands Map:

- There is a Palustrine Feature (Section 14) that appears to correspond with the pond you have shown on the maps provided. The buffer is 200 feet (MCC 38.7075(A)(2)(a))
- There is a Linear Stream Feature (Section 14, 15, 23, and 24) that appears to correspond with Coopey Creek. The buffer is 50 feet (MCC 38.7075(A)(2)(b))

#### NSA Sensitive Wildlife Map:

• There is a Special Stream feature (Section 14, 15, 23, and 24) that appears to correspond with Coopey Creek. The buffer is 50 feet (MCC 38.7075(A)(2)(b))

#### NSA Sensitive Plants Map:

- There is a Significant Natural Area that appears to correspond with the Oregon White Oak habitat I saw on site during the visit, this area is located to the east of the creek. The buffer is 200 feet (MCC 38.7075(H))
- There are two sensitive plan areas identified (Blue Triangle and Black Triangle) that appear to the east of the site. The buffer is 200 feet (MCC 38.7075(H))

#### NSA Deer and Elk Winter Range

No resources identified within the plan area.

#### Next Steps:

MCC 38.7090(C) requires that an application for post-emergency/disaster response be submitted within 30 days of the notification. We received the official notification from ODOT on 9-12-17 requiring the application to be submitted by 10-12-17. Please note that an extension can be requested in writing for up to 30 days. The County is limited to granting two (2) extensions for no more than an additional 60 days which means the application will need to be submitted no later than 12-11-17.

We hit a bit of a snag at the Planning desk today when we tried to turn in our Coopey Quarry Disposal Site permit. I am officially requesting another 30 day extension so we can make sure we are all on the same page moving forward. One of our ODOT staff came in with the Coopey Quarry Disposal site fill NSA permit and there was confusion about why we were submitting that instead of the Emergency permit. I thought our previous discussions were leading us to one permit only, the one we tried to submit today. Let's get this clarified.

Thank you. I need to schedule a meeting with you to discuss the permit that I believe I am submitting, which is for the Coopey Quarry Disposal site. It's a full NSA permit detailing our proposed action. I did not plan to submit a permit for any Emergency activities that are on-going as a result of the fire. The highway is still closed as part of the post emergency clean up and the USFS Closure Order. We are doing work in coordination with other agencies (OPRD and USFS) mitigating hazard in order to reopen the HCRH. George told me over the phone that all the activities taking place on and adjacent to the HCRH are subject to a permit. I tried to explain that all we are doing is ditching, hazard tree removal (partnering and with input from USFS and OPRD) and rock scaling to alleviate the hazards so we can open at least segments of the highway once it is safe. We understand that any permanent fixes, hard-scape (fences, mesh, walls) will require an NSA permit and we are still hoping to discuss some kind of programmatic approach with you.

Let's meet and get on the same page. I understand the natural resource side and the Coopey Quarry permit documents and I have been involved along the way the post-fire emergency response and hazard mitigation, but I am less comfortable with the County permitting process. I would like to set up a meeting, and I'll bring Terra with me, so I can get my arms around what is needed. I only have until mid-December to get this all together since I've burned up over 60 of my 90 days. The sooner we chat the better. Please let me know your availability. I'll leave it up to you to invite who needs to be there from the County side.
