# Introductions, Announcements, and Approval of Minutes

Chair Deborah Kafoury noted the passing of former Portland Mayor Vera Katz.

Introductions were made.

The November minutes were approved.

Mayor Ted Wheeler recommended that representatives from Black Male Achievement have

a seat at the LPSCC table.

Lane Borg is leaving Metropolitan Public Defenders. MPD will have an interim director.

# Multnomah County Gang Assessment Implementation Upgrade

Suzanne Hayden provided the history and background of the OJJDP Comprehensive Gang Assessment. After the assessment was completed in 2015, there was a year of strategic planning. Implementation began in early 2017. Updates from each strategy were provided. Highlights include:

Strategy #6: Links Between Police, Youth and Communities:

Lakayana Drury introduced youth from <u>Word is Bond</u> (formerly Full House Solutions) and Multnomah Youth Commission (MYC). The presentation included an MYC and Youth Against Violence Committee overview, Word is Bond Overview, accomplishments, and areas of engagement. A video was shown. See the <u>presentation</u> for more details.

Strategy #5: Parent Partnerships

• POIC's Kim Filla, Annette Majekodunmi, and Michelle Carter gave an overview of strategy 5, which focuses on relationships with parents. They have created a parent handbook that is being finalized.

Strategy #4: Employment Opportunities

- POIC's Lanya McClintock and Demarcus Richard shared several key strategies:
  - Working with the CHI Elevate program (26-28 participants), specifically helping gang involved participants find jobs
  - Using internship dollars they received to target gang-impacted youth.
     Specifically, using internship dollars to ensure youth receive pay when working on internship or pre-apprenticeship program (only paid pre-apprenticeship program in the state, soon to be certified by BOLI).
  - Collaboratively working with A Home For Everyone to find employment for gang impacted participants.

Strategy #3: Connection to Schools

- Takeaways include:
  - School is one of the single most dynamic protective factors for kids impacted by trauma and violence when they are engaged and supportively connected.
     Stakeholders are working to amplify existing expertise and relationships that benefit all schools and all youth.
  - When youth are successfully connected to school, they are less likely to resort to violence as a way to address barriers, thus increasing public and school safety.
  - The strategy can be used for both prevention and intervention, adopting strategies that are both universally supportive and targeted.

Strategy #2: Mentors that Get It

- Julia Mitchell (POIC) and Eric Zimmerman (District Attorney's Office) shared the following activities:
  - Developing a network of organizations with mentoring programs that

serve gang-impacted youth or those experiencing risk factors for gang involvement. Hold monthly cross-agency peer support meeting for both formal/informal mentors. This group would identify training needs as well as share their expertise with one another.

- Developing a centralized place for information to be posted about training opportunities for formal and informal mentors.
- Hosting a Mentor Network Kick-Off /Conference in the Spring.
- Future Goals:
  - 1. Reducing barriers for mentors with lived experience.
  - 2. Re-entry coordination with OYA and Department of Corrections.

# Multnomah County Justice Reinvestment Program Supplemental Work

Judge Nan Waller, Scott Taylor, David VanSpeybroek, Tim Hartnett, and Caroline Wong provided an overview of the <u>Justice Reinvestment</u> Supplemental grant and associated programming. Multnomah County received an additional \$1.6 million over 18 months from the State to continue and expand Justice Reinvestment. The program will focus on women and young adults aged 15-25 while working to reduce racial and ethnic disparities.

Supplemental grant-funded personnel will be added to several agencies, and 10% is designated to non-profit victims' services.

## **FUSE Grant**

Heather Lyons presented on <u>FUSE</u> (Frequent User Systems Engagement), which brings together systems to share data on frequent users to help find housing and services. The Corporation for Supportive Housing has applied for a grant to Meyer Memorial Trust Members of LPSCC, Legacy, CareOregon, Kaiser Perm, Community Based organizations, Self-enhancement inc. See the <u>handout</u> for more information. If funding is granted, the process will start in January.

#### Other

Judge Nan Waller thanked Chief Criminal Court Judge Edward Jones and recognized his retirement with a plaque. Other members thanked him.

Sheriff Mike Reese recognized Lane Borg and others shared comments.
