Executive Summary

The Aging, Disability & Veterans Services Division (ADVSD) Public Guardian and Conservator Program (PGC) protects older adults, people with disabilities, and Veterans under court authority. This program offer purchases a new software system to replace an at-risk legacy system that provides essential information for programmatic decision making. The result will be a stable, secure system with improved reporting capacity and the ability to measure quality outcomes for clients.

Program Summary

ISSUE: The PGC IT System Replacement project will reduce client and program risk and improve service delivery by modernizing technology. The project replaces the current outdated, unsupported, and fragmented at-risk legacy system. The primary data systems are Microsoft Access databases developed twenty years ago and are now minimally supported within the County and are at risk for cataclysmic failure as assessed by County IT. A 2016 County audit found the system does not meet auditing standards and supported replacement. A project team reviewed performance issues and determined that the PGC financial system could not meet accounting standards and was replaced. However, the PGC client data system remains fragmented and does not currently meet County security standards. County IT has spent 100+ hours in the last two years fixing crashes, maintaining operations, and addressing remote access issues. IT can only provide basic technical support to keep the system running which prevents PGC from complying with department equity data standards for collecting race and ethnicity data to identify disparities and report on performance metrics.

PROGRAM GOAL: Deputy public guardians spend significant time away from the office and provide 24-hour on-call coverage, yet have limited and unpredictable access to the information they need to effectively serve 180+ protected persons under court authority. The Public Guardian is legally bonded, certified, and insured because of the litigation risks associated with the program's fiduciary duties. The current system cannot adequately safeguard the program from lost files or information, which could potentially have legal impacts for the County and pose safety risks for their clients. The new system will provide access to critical client information while staff are away from the office responding to medical, residential and other provider inquiries in addressing care and safety needs. The system will also provide accurate and accessible data needed for decision-making, program performance, and statistical reports.

PROGRAM ACTIVITY: The purchase of an online vendor-based solution to replace the current system will require one-timeonly funding to cover initial costs for data migration, customization, and implementation to provide an accessible, stable, improved platform for data integrity and service delivery. This program offer is connected to 25026C and will sustain the new system through ongoing web-based access to data and record management that meets industry and legal standards for providing quality guardianship services.
