**Program Description:**

The Office of Diversity and Equity (ODE) is the hub for Multnomah County diversity and equity initiatives. Our mission is to ensure access, equity, and inclusion in Multnomah County's services, policies, practices, and procedures.

ODE works with all County departments, various community groups and County citizens to achieve and promulgate Multnomah County's goal of providing an equitable, diverse, safe and inclusive workplace. ODE offers training and consulting; policy, practice and procedure review; and technical assistance, among other services. The office also coordinates community events, organizes an annual diversity conference, facilitates conversations, and assists in the creation and implementation of diversity and equity initiatives, including the countywide Workforce Equity Strategic Plan.

**Job Description:**

This position will support the research and evaluation work related to the Workforce Equity Strategic Plan (WESP) as well as other work as research and evaluation work assigned to the Office of Diversity and Equity (ODE) at Multnomah County.

We are seeking someone with advanced undergraduate research and evaluation skills and who has knowledge of public policy and a commitment to social justice. Excellent writing and organizational skills, attention to detail, and experience with Excel, Survey Monkey, and either/both SPSS and Atlasti. This position will provide you with a range of opportunities to learn about ways to use research and evaluation work in the service of equity and inclusion work in a government setting.

- Create charts, graphs and other figures for reports and presentations
- Ability to honor research ethics and standards of confidentiality regarding County projects and data
- Ability to both develop and follow complex workplans as well as research and evaluation designs

- Demonstrated ability to work in a team environment and proven ability to function independently
