Kirsten Snowden opened the meeting. Introductions were made, and the ice-breaker was what are you looking forward to during the holidays this year?

Updates/Announcements

- Suzanne Hayden noted the 4th annual Building Bridges of Understanding in Our Communities event on October 24th. This year's theme is confronting hate. Register here
- Tonight's PCCEP meeting is a community discussion on gun violence in Portland, and will include information about the Gun Violence Reduction Team.
- Anya Sekino announced a summit, in partnership with the Oregon Youth Authority, on minority youth representation. If interested, contact Anya.



Law Enforcement & MCDA Updates

- Sgt. Aaron Schmautz of Youth Services Division noted it's been a busy start to the year. Up to 50 threat assessments have been completed this school year.
- Commander Art Nakamura represented the Gun Violence Reduction Team (GVRT).He cited 318 shootings in the city this year. GVRT uses new technology to connect guns to shootings. Findings include that just a few guns are being used in multiple shootings. Data should be available in the next month or two.
- Kirsten Snowden noted MCDA has a designated team for high volume-repeat offenders.

Ceasefire Strategy Project

Tom Peavey created and distributed a Ceasefire Strategy Project brief and update that included timeline, project costs, scope of work, measurables, and other details. Discussion points included:

- The average age of someone involved in homicide in Portland is 35. Concerns were raised whether this was misleading and might chill the investments in youth violence.
- Conflicts are interpersonal, but are grouped into group/gang.
- The life coaches are key to the strategy.
- A report on the problem and cost analysis will be out in November.

Marcia gave an update on the 6 workgroups. Each workgroup is coming up with a charge document:

- Coordinated Entry: Charge is to develop a proposal. Due to the cross departmental violence prevention to suppression framework coming out of Commissioner Stegmann's office, this work may be duplicative, and so they are on hold for now.
- **Mentor Network**: Monthly attendance dwindled, so Marcia put the group on hold. Marcia sent out an interest form to hundreds of mentors and received 12 responses.
- Connection to Schools: This group is committed to completing their charge document.
- **Employment Workgroup:** On hold due to the new things happening with SE Works, which may end up being duplicative. Will meet individually to figure out how to move forward.
- Parent Partnership Workgroup: Decided they no longer need to hold listening sessions. May hold listening session with both parents and mentors.
- Links between Youth, Police and Community: Needs Gresham representation. Working on charge document.

Public Health & Criminal Justice

Kallie Kurtz referenced the workgroup started by Commissioner Stegmann's office. This group is working on cross departmental violence prevention to suppression framework rooted in public health. It will focus on overlapping root causes of multiple forms of violence (sexual violence of all types including coercive trafficking, intimate partner violence, child abuse, gang violence, etc). A preliminary cost analysis of all violence prevention/intervention/suppression at the county was just completed.



The Violence Prevention Coordination Team will be presenting their two recommendations at the October LPSCC meeting.

The public health discussion will continue at future meetings.
