Executive Summary

Dental Services provides County persons with essential, urgent, routine, and preventive services in clinic settings and school-based programs. Program works with community partners, targeting under-served populations; providing service to nearly 27,000 people in Multnomah County. The Dental Program is the largest Safety Net provider for vital dental care in the County and additionally provides child based services to uninsured and underinsured clients (School of Community Oral Health); focuses on access for clients with chronic diseases, children and pregnant women. The program uses evidence based practice guidelines

Program Summary

North Portland currently does not have a low income, Medicaid focused, or free dental clinic in the region. Recognizing this as an access and health outcomes disparity, in 2019, Multnomah County worked with HRSA to obtain a grant which would partially fund the expansion of dental services in North Portland - this represents a significant service opportunity focused on equity for North Portland residents. While the HRSA grant will be able fund four operatories in North Portland, this one-time-only request would allow the County to open two additional operatories. This specific funding for the 2 chairs at NP is expected to serve an additional 1000 new patients, with many currently engaged with primary care at North Portland Health Center. This will increase the number of new dental patients and help the FQHC provide all three services at full capacity (primary care, pharmacy, and dental services) in support of patient-centered care design.
