### Job Task Description:

The role of Victim Services Intern will be to assist the VSU in adhering to our strategic plan goals by:

- Notifying victims/survivors when DCJ begins supervising a new case in which they are the listed victim and providing information about victims rights, resources, and contact information for Probation/Parole Officers and advocates.
- Researching best practices for providing culturally responsive services and collaborating with VSU staff to integrate these practices into our services.
- Assisting VSU in embedding it's vision, mission, and values (equity, trauma-informed, and survivor led) into practices and policies by creating tools to utilize core values in decision making, providing training, and facilitating group discussions.
- Creating infrastructure for collecting feedback from victims/survivors connected to DCJ by preparing action plans, analyzing data, writing reports, and disseminating information.
- Participating in staff meetings.
- Performing administrative duties as needed.
