### Welcome & Introductions

People introduced themselves and shared something they learned this week.

#### **Information Sharing & Updates**

- Strategy 5 Parent Partnerships: Parent conference is May 16th at POIC East.
  - Currently developing workshops (IEPs, DV, ICE, etc).
    - SummerWorks sign ups.
    - Need funding for childcare, lunch & breakfast.
    - Need connection with Gresham Schools.
    - Opportunity to table or present in workshops.
- Abbey noted the April LPSCC Executive Committee meeting will focus on gun violence data from Law Enforcement and other agencies.
- MCDA: Currently already short DAs and now faced with another reduction. Various options on the table.
- DCJ: Budget will be released tomorrow and Mary can provide updates afterwards.
- PPB: Funding for GVRT is still up in the air. Down from 12 to 9 officers and losing a couple more. Force is 130-200+ short.
- Discussion around ease of youth getting firearms.
- Healing Hurt People (HHP) model: handout was distributed. HHP is a health-based program that serves individuals of color, ages 10-45, who have experienced intentional trauma such as gunshots or stab wounds. Key component is to intervene within 4 hours. HHP staff can go into emergency rooms at Emanuel Hospital. (Have not yet gotten into OHSU--Abbey can make an introduction).
- Tom Peavey: *Bleeding Out* is a recommended reading for talking points around the hybrid of programs. Tom noted Health-based programs are essential.



## Debrief on Youth Based Meeting in December:

Mary Geelan: question about impacts on specific groups of color could be included in presentation.

Abbey offered to connect with Elana to talk about other audiences.

Next May meeting: Multnomah Health Youth Advisory is creating a video. (Quete).

## Gang Pathways Research

Presenters were out sick, but Lily noted local youth have told us adult mentors would have made a difference.

Mary noted the work with OYVP will help us see a bigger picture of the mentor network. OYVP would like to provide professional development to build up mentoring capacity in the community.
