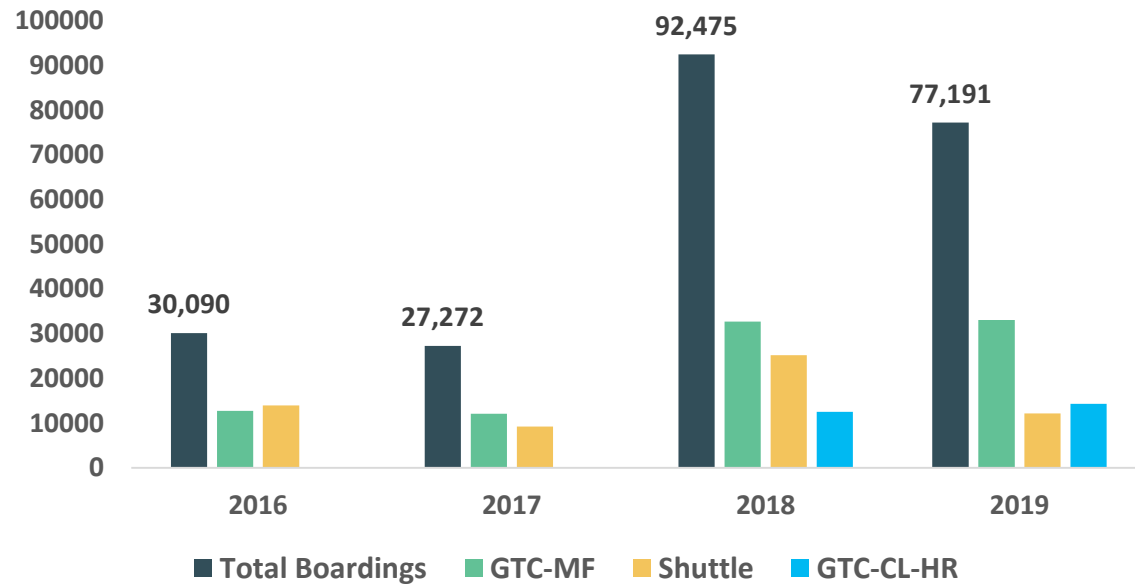


CGE Ridership

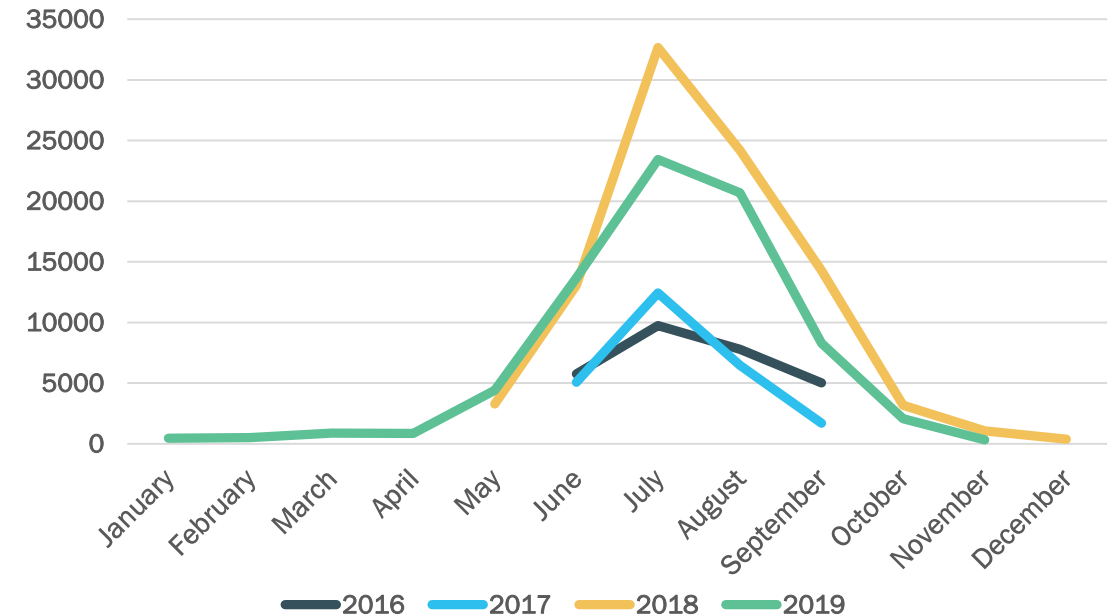


CGE transported a total of **226,704** one-way trips through the Gorge since its inception in May 2016 through the end of the fall shoulder in November 2019

2019 Trends:

49% of riders had no access to a vehicle or no other option to get to their destination

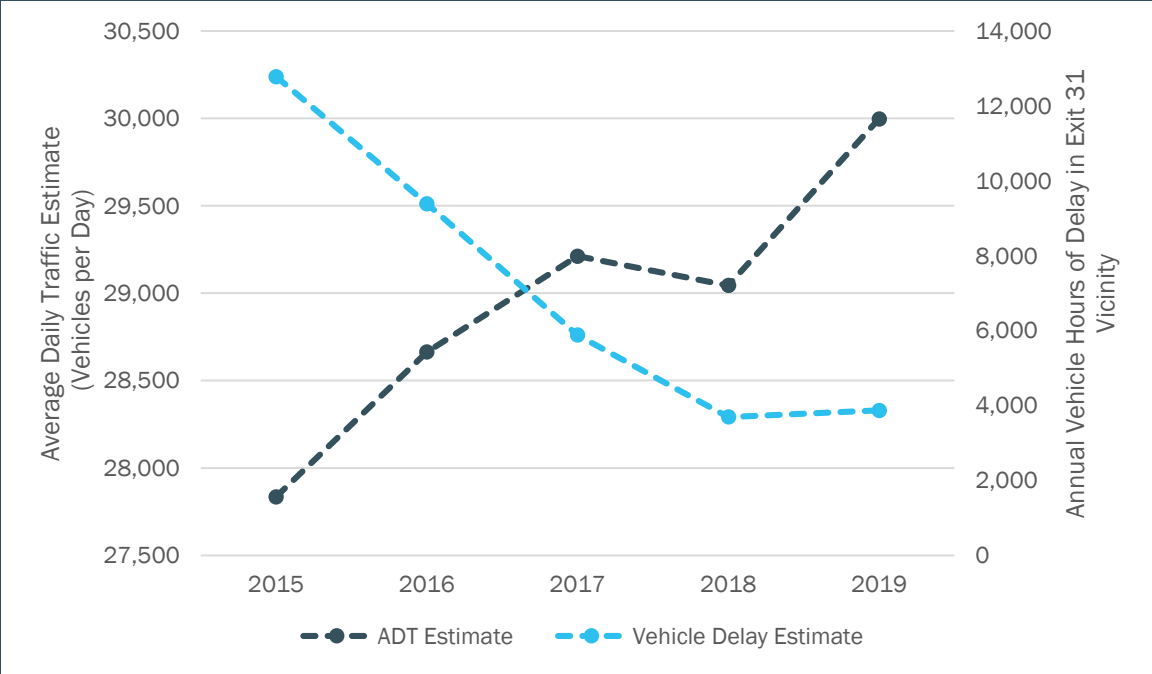
Among riders that live in the Portland Metro, 57% reported not having access to a vehicle (8% of the metro population does not have a vehicle in their household)

35% of riders in represented people of color

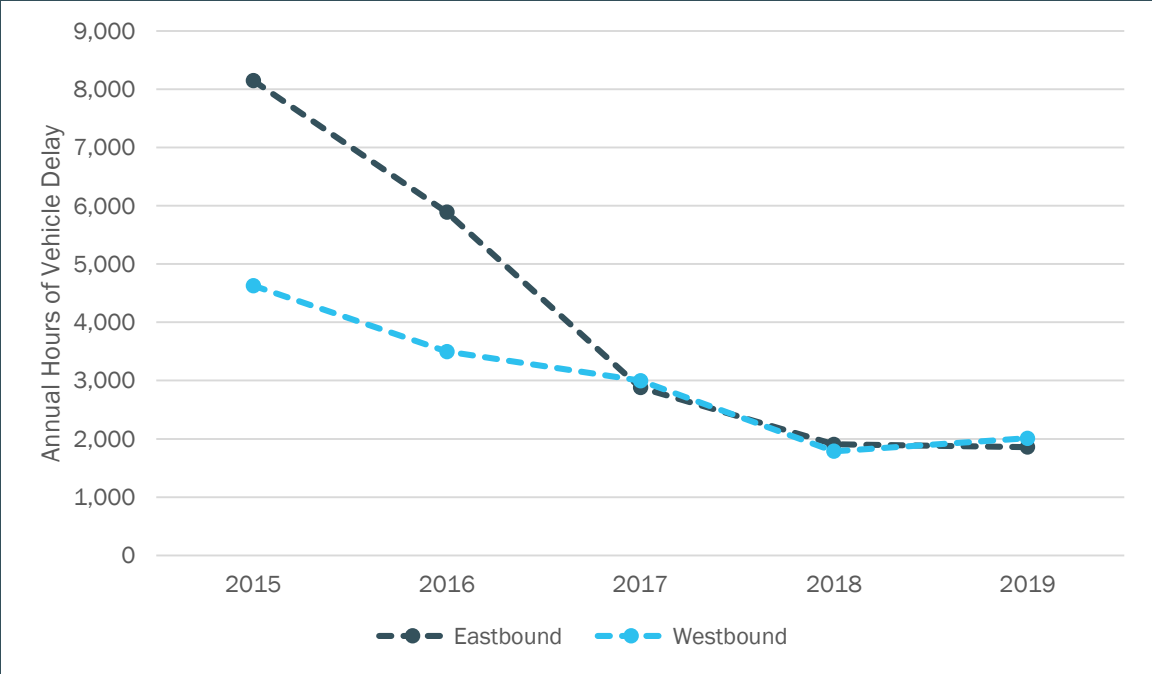




Average Daily Traffic and Vehicle Delay in Vicinity of Exit 31 (Multnomah Falls)

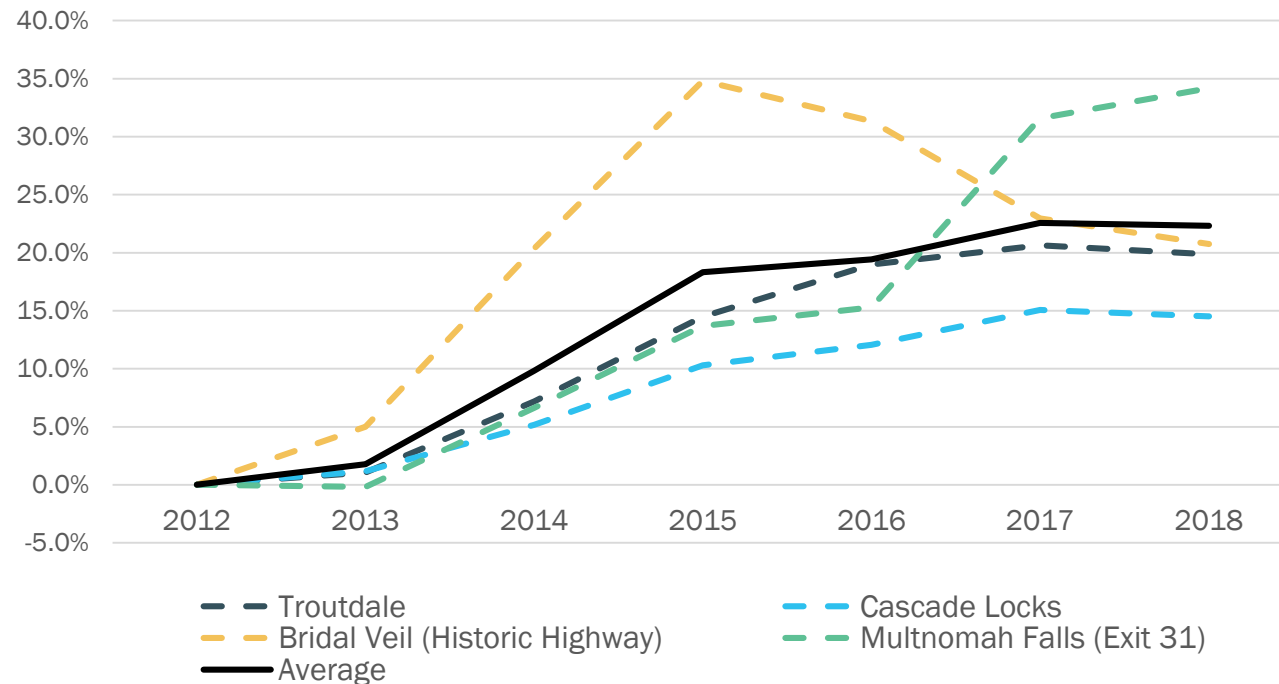

% Change in Average Daily Traffic at Traffic Counters located at and near Multnomah Falls, 2012-2018



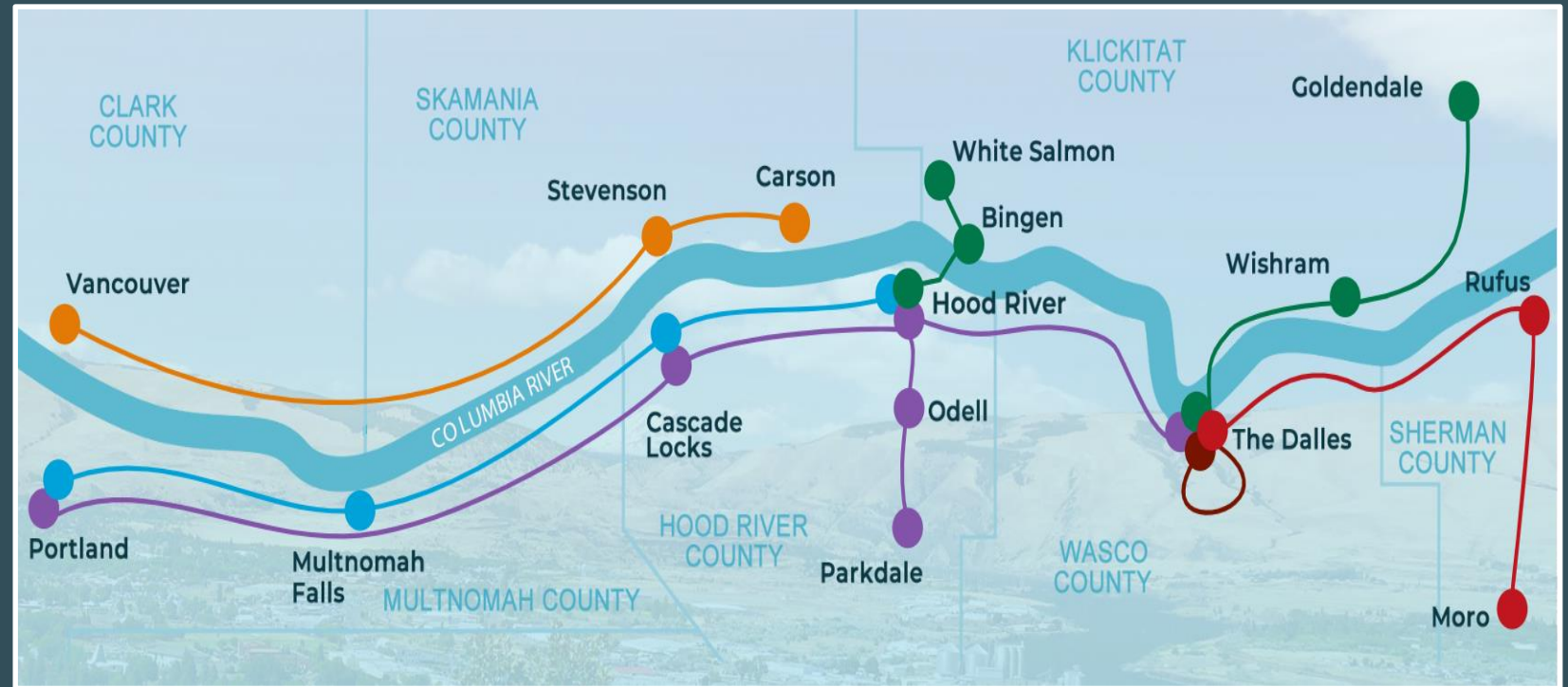
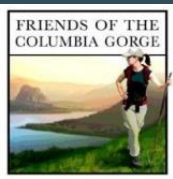
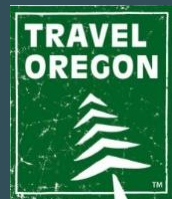
Takeaways

CGE and Bikes



- Accommodating cyclists has been a priority since CGE's inception
- Promotes and enables cycling for both recreational and utilitarian purposes
- CGE buses can accommodate up to 3 bikes

CGE and Bikes

Challenges

- Bike racks are filled on a first come first served basis, no reservations
- CGE grant included funds for bike trailers; program owns two 12-bike trailers but the configuration of Gateway Transit Center does not have enough space for bus + trailer setup
- Few easily-accessible biking destinations near CGE stops



CGE and Bikes

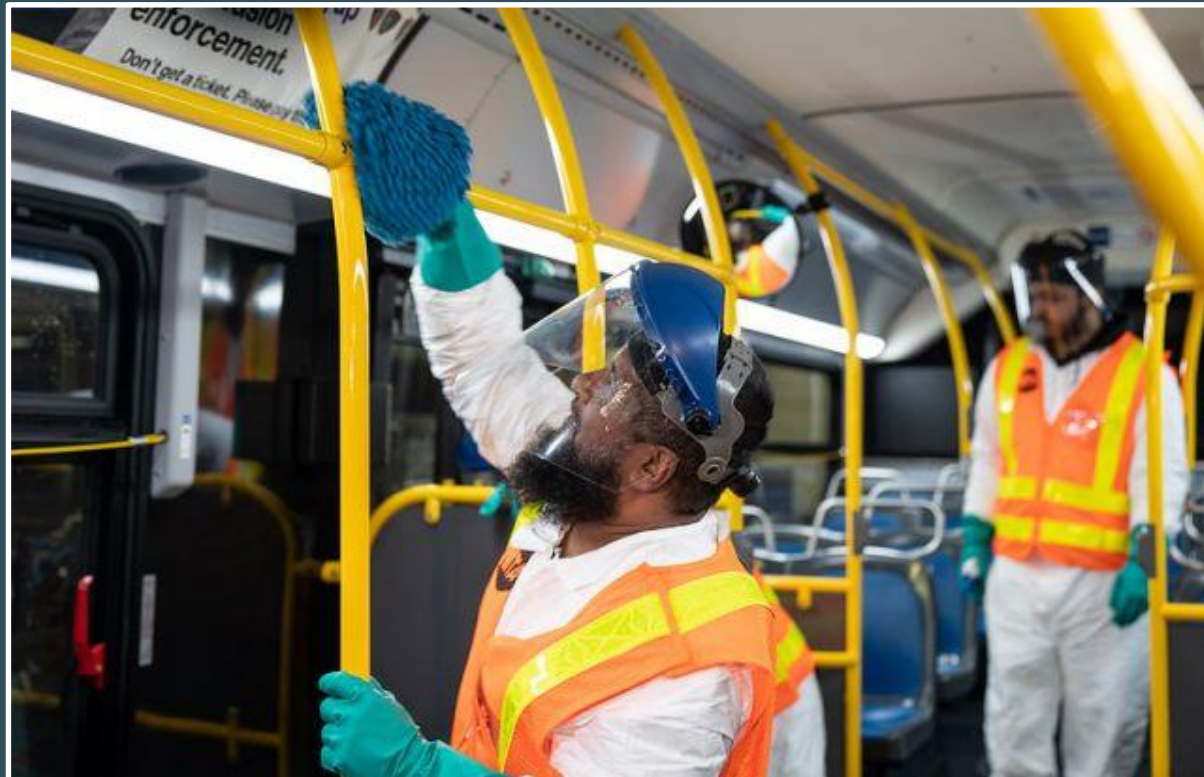


Solutions and Opportunities

- Columbia Area Transit can use the CGE bike trailers by establishing a temporary stop on NE 99th Ave for when trailers are attached
- Historic Columbia River Highway State Trail expanded by 3 miles in 2019; when complete there will be 22 miles of car-free trail

Summer 2020

CAT-run intercity service

- CGE intercity service suspended March 24
- Introduced Dial-A-Ride service on May 11, will expand based on state and county guidelines
- Implementing measures to ensure passenger and driver safety
- Emphasis on essential travel
- Eligible for CARES funding/reimbursement



Summer 2020

ODOT-run Multnomah Falls shuttle

- Forest Service does not yet have plans for reopening Multnomah Falls
- Significant increase in operating costs due to limited capacity and sanitation / staffing
- Purely recreational



And beyond



Ensure transit continues to be seen as a resource in the present, near-term and long-term along the I-84 corridor, serving both critical and recreational needs
