Dear Military or Overseas Voter:

Enclosed is your ballot for the November 3, 2020 General Election. More information on the 2020 General Election is available at <u>www.mcelections.org</u>.

If you only see Federal Offices (U.S. President, U.S. Senate and U.S. Congress) on your enclosed ballot, you are receiving a Federal Only ballot. This is because when you registered you marked that your return to the U.S. was uncertain. If you wish to receive a full ballot with state and local candidates and measures, please update using the Federal Post Card Application (FPCA) registration form and mark that you intend to return. You can scan and email the signed form to us at <u>elections@multco.us</u> The FPCA registration is available at <u>fvap.gov</u>.

- Due to the COVID-19 pandemic, mail service disruptions have occurred and your mailed ballot may not arrive in time to return your ballot by mail.
- Military and overseas voters registered in Oregon have options in voting. Those options include how to mark the ballot and how to return the ballot.
- Military and overseas voters can return their ballot by mail, fax or e-mail and have the choice of marking the enclosed paper ballot or using the online ballot-marking tool.
- If you wish to use the online ballot-marking tool, please see the Voting Instructions for Military & Overseas Voters at <u>https://sos.oregon.gov/voting/Pages/instructions-overseas.aspx</u> that will direct you to My Vote. Please note the online tool is not available in some countries due to online security issues. If you cannot access the online tool for any reason, please contact us at <u>elections@multco.us</u>.
- If you wish to mail your ballot back using the prepaid postage on your ballot return envelope, you must mail the envelope at a U.S. post office, an overseas U.S. military post office, an American Embassy, or an American Consulate. Visit <u>Travel.State.Gov</u> for more information. Otherwise, you will have to pay the postage to return your ballot.
- If you wish to fax or e-mail your enclosed ballot you **MUST** complete all of the following 4 steps:
  - 1. Complete your ballot AND
  - 2. Sign your return envelope AND
  - 3. Complete and sign the SEL 531 form on the back of this letter AND
  - 4. Fax or e-mail back **the SEL 531 form**, the **signed return envelope** and the **ballot** to 503-988-4559 or <u>elections.ballot@multco.us</u> by 8:00 PM, November 3, 2020. Your ballot cannot be counted unless you sign the form and return envelope.
- Voted ballots **MUST** be received by **8:00 PM**, **Tuesday**, **November 3**, **2020**, to be counted. **POSTMARKS DO NOT COUNT!** Please return your ballot promptly.
- For confirmation that your ballot was received, log into My Vote (link above) or sign up with our program that allows you to track and receive status updates about your ballot at <a href="https://multco.us/trackyourballot">https://multco.us/trackyourballot</a>.
