Program Manager's Letter

Dear Providers:

The pandemic is likely to continue through the spring. Below are a few reminders as you continue to deal with this crisis.

Homes are still closed for non-essential visitors. Virtual visits and outdoor visits are encouraged. See page 3 for more on outdoor visits during the winter months.

It is important to conduct weekly activities to support mental stimulation and social connection during this time.

Renewal applications are sent out via email 90 days prior to your license expiration. It's your responsibility to ensure we get your completed application 30 days prior to your license expiration date. You can fax, email or mail your application. We will email you a receipt. If your license expires before we receive your application the license is closed.

PPE is still recommended for all caregivers, especially those who leave the ACH. Masks continue to be required for all caregivers who work or live outside the home.

Quarantine those who have been exposed.

Remember it is important not to make residents feel they are being punished for choosing to take outings.

Again, **thank you** for your commitment to resident safety. I am so proud of our network's resilience and dedication. You have shown so much personal strength in nagativing these challenging times. Remember we are here to support you.

Free Gloves & Masks for Small Businesses

Governor Brown has announced a new program to provide FREE gloves and masks for small business owners during the COVID-19 pandemic.

How much can I order?

- 0-9 employees: 100 masks and 1 box each size gloves (medium & large)
- 10-25 employees: 300 masks and 2 boxes each size gloves (medium & large)

Renewal Inspections Update

Renewal visits have been delayed by fires and hazardous air quality; however, we expect to resume inspections October 1st. These visits will be unannounced and mostly conducted outdoors but will include a quick walk-through of the house and focus on environmental hazards and fire safety. Licensers will wear masks and gloves. Please screen all licensers before entry.

Change in CDC COVID-19 Strategies

According to the CDC, current evidence supports using a **symptom- based strategy** to determine when individuals with COVID-19 are no longer infectious. Reportedly, people with mild to moderate COVID-19 cases remain infectious for about 10 days after the start of symptoms and people with more severe cases, or who are severely immunocompromised, remain infectious for about 20 days after symptoms begin.

Please remember that any suspected, presumed, or confirmed COVID-19 infections must be reported to the ACHP. Call 503-988-3000 and ask for the licenser of the day.

Updated quarantine recommendations:

- Individuals with COVID-19 who have symptoms and are directed to quarantine may discontinue if the symptoms have resolved and it has been at least 10 days since symptom onset (start of symptoms).
- 2. Individuals who test positive for COVID-19 but who never develop physical symptoms may discontinue quarantine and other precautions 10 days after the date of their positive test result.
- 3. Hospitalized residents may be readmitted to your home if symptoms have resolved and it has been at least 10 days since symptom onset (start of symptoms). There is no longer a need to require two negative tests before readmission into your home at this time.

Testing will occur weekly. Capacity is limited to nine people. Everyone will be screened and kept six feet apart, and masks are required. Please contact us if there is a medical condition that does not allow you to wear a mask or if you don't have a mask.
