Authorizing the Repurchase of Tax Foreclosed Property as Allowed under ORS 275.180 by Former Owners, George and Pam Staton and Execution of Deeds and Contract

The Multnomah County Board of Commissioners Finds:

- George and Pam Staton are the former owners of certain real property, more particularly described in a. the proposed deed to ("Former Owners"), attached and identified within Exhibit I ("Contract") as Exhibit A ("Property").
- On or about October 5, 2018, judgment was entered in Multnomah County Circuit Court foreclosing the b. delinguent taxes levied against the Property.
- On October 6, 2020, the County Tax Collector deeded all right, title and interest in the Property to C. Multnomah County as authorized under ORS 312.200.
- d. Former Owner has applied to the County in compliance with MCC Section 7.402 to repurchase the Property for \$46,505.00, plus interest and expenses ("Repurchase Price"), an amount consistent with ORS 275.180 and MCC Subsection 7.402(B). The County will receive payment of the Repurchase Price under the terms of a Limited Term Repurchase Contract of Sale ("Contract") attached and identified as Exhibit I. The Contract temporarily conveys the Property to Former Owners to facilitate a refinancing or sale, with a reconveyance deed to County should the Contract not be completed, attached as Exhibit B within Exhibit I.
- It is in the best public interest that the Property be sold to the Former Owner as described above in e. Paragraph d).

The Multnomah County Board of Commissioners Resolves:

The County Chair is authorized to execute the Contract and associated deed and reconveyance deed, and related escrow documents, in substantial conformance with the attached Exhibit I, conveying the Property to George and Pam Staton.
