# RESOLUTION NO. 2021-013

Authorizing the Repurchase of Tax Foreclosed Property as Allowed under ORS 275.180 by a Former Owner, TEE BEE Enterprises, LLC

## The Multnomah County Board of Commissioners Finds:

- a. TEE BEE Enterprises, LLC is a former owner of certain real property, more particularly described in the proposed deed to ("Former Owner"), attached and identified as Exhibit A ("Property").
- b. On or about October 5, 2018, judgment was entered in Multhomah County Circuit Court foreclosing the delinquent taxes levied against the Property.
- c. On December 1, 2020, the County Tax Collector deeded all right, title and interest in the Property to Multnomah County as authorized under ORS 312.200.
- d. Former Owner has applied to the County in compliance with MCC Section 7.402 to repurchase the Property for \$88,134.00, an amount consistent with ORS 275.180 and MCC Subsection 7.402(B). The County has received confirmation that payment in the amount of \$88,134.00 is deposited in escrow on behalf of Former Owner's repurchase.
- e. It is in the best public interest that the Property be sold to the Former Owner as described above in Paragraph d).

## The Multnomah County Board of Commissioners Resolves:

The County Chair is authorized to execute escrow instructions and a deed, in substantial conformance with the attached Exhibit A, conveying the Property to TEE BEE Enterprises, LLC.
