Federal me state officials ra pesei sopweno neaea ewe oppos Johnson & Johnson (J&J) mwurin ewe 10-ran e kouno fan ewe April, 2021. Kounon ewe safei faniten kewe sou safei repwe weweiti ochuw kewe nikinik mei fis ngeni ekkoch aramas ra osukosuk ren fetaningawen char mwurin ar angei ei oppos.

Ei watten efeiengaw ren pekin fetaningawen cha non kewe wa non tumwu, nuk ika peche fiti kukunun fetanin platelets (Ewe sokkun monun non cha e anisi inisum an esapw pwuno chamw). Itan thrombosis fiti thrombocytopenia syndrome, ika TTS. Ei condition ika monumon a unusen efeiengaw pwun sia tongeni mano ren, nge a pwan tongeni safei an esapw wor osukosukan. Fofforun safean mei sokono seni ekkoch sokkun fetaningawen cha.

TTS ese kon fiffis. Sou tipachem ra ouku pwun 7 me nein 1 million fefin mei oppos nefinen ier 18 ngeni 49 ra mefi ei. Ren fefin ier 50 etta me mwan ier ese pwan nifinifin, ese kon fiffis ngenir ei osukosuk, nge mei pin fis.

Sou tipachem kewe ra kae TTS non nour kewe patient kewe ra angei ei oppos Johnson & Johnson ra opwungano pwun ei safei Johnson & Johnson a watte namwotan ngeni aramas nap seni kewe efeiengaw. Kewe efeiengaw ren mano faniten fetaningawen cha seni ei semwen COVID-19 a kon watte efeiengawan nap seni an epwe fetaningaw cha seni ewe oppos.
