Provider Updates	
Adrian Burris and Amee McFee - 4D	No major updates since last meeting and no notable changes to COVID-related procedures due to updated guidelines. 4D is doing outreach for vaccinations, which included hiring a person to distribute materials within the County. PPE - Natalie will follow-up regarding need for new masks.
Dana Boddy – Alano Club	Alano is now at 50 % capacity, with two largest meeting rooms going up from 25 people to 50. No PPE needs. The Peer Connect program is now working with 4 full time mentors. Looking to expand. About half of peer services remain virtual.
Jocelyn Di Priest – CRC Allied	No PPE needs at this time and we haven't changed anything from previous weeks, still social distancing, and haven't returned for inperson counseling.
Nick Guerrero – Raphael House	Discussions of changes to operations are ongoing and looking at how things may change in the next few months. To date, there have been no changes to mask and social distancing requirements. Reopening of PPS in the fall will make working easier for staff, and there are currently conversations being had around what those transitions are going to be like. Staff may work under a hybrid model and programs are currently being mapped. Shelter is still at capacity. Our recovery mentors are doing virtual support and meeting up in person, making plans for meeting up in parks, café and open-air places, and keeping up with guidelines and fielding the questions, encouraging those conversations at work. No PPE needs right now.
Julia Mines - Miracles	Miracles is not planning on changing any COVID procedures because the impact within the community served. No PPE needs. Miracles offered to host COVID testing and for vaccines but no one contacted us about utilizing our services. The AD team will follow-up with County partners about this.
Olga Parker – Modus Operandi	Still seeing our groups in person, but still keeping social distancing and using masks and encouraging vaccinations. Russian community has been hesitant about getting vaccinations due to mistrust. Modus has been providing information about vaccinations to help build trust. No PPE needs.

Belinda Kjensrud - Morrison CFS	Still wearing masks, working remotely, and meeting with parents virtually. Mentors can meet with a parent one to two times a month and with no more than one parent a day. No PPE needs. Exciting news, we applied for and were awarded the OHA grant and received everything we asked for, including funding for six positions. From Multnomah Co, we asked for one African American mom and one African American dad. We start recruiting next week. Hoping to have people start training in July.
